उपरोक्त विषय पर आपके कार्यालय पत्र संख्या FHE/SHP/Suil-IV-0071 दिंनाक 10 अगस्त, 2021 के सन्दर्भ में मांगी गई सूचना क्षेत्रिय राजस्व इकाई से तैयार करवाई गयी। मुताबिक रिपोर्ट तहसीलदार सलूणी कर्म व मीटर का औदित्य इस प्रकार से है।

हिमायल प्रदेश भू—राजस्व अधिनियम, 1954 के अनुसार चम्बा में कानूनी बंदोबस्त वर्ष 1954 से 1960 तक हुआ है तथा जिले का पैमाना 56 इंच प्रति करम के हिसाब से दर्ज कागजात है। एम0/एस0 फेंड्स हिम एनेर्जिज द्वारा विद्युत संचारण रेखा (Transmission line) अवयव को 15 मीटर कॉरिडोर के लिए भूमि अर्जित की जा रही है। परन्तु राजस्व अभिलेख में करम के हिसाब से पैमाइश है इसलिए मीटर में मौका ततीमा बनाया जाना असंभव है, इसलिए हिमाचल प्रदेश राजस्व विभाग के अनुसार 15 मीटर = 15/1.42 = 10.5633 (karama) करम आता है। जिससे कुल क्षेत्रफल कम पड जाता है। हिमाचल प्रदेश राजस्व विभाग के माप के अनुसार करम (Karama) मीटर में विभाजित नहीं होते है करम (Karama) को पूरा—पूरा लेना पड़ता है। इसलिए कुल चौडाई 11 करमों (Karama) में लिया है। राजस्व विभाग के माप के अनुसार एक करम (Karama) =1.42 मीटर होता है। अगर 11x1.42=15.62 मीटर के बराबर आता है।

तदानुसार परियोजना के निर्माण के लिए कुल चौडाई बढाकर 11 करमों (Karama) में लिया गया है। हिमाचल प्रदेश राजस्व इकाई के अधिनियमानुसार न्यायसंगत, औचित्य विकल्प निकाल कर ट्रांसिमशन लाइन की कुल चौडाई 15 मीटर न लेते हुए 15.62 मीटर रखनी होगी यानि 10.5633 करम (Karam) न लेते हुए 11 करमों (karama) में लिया जाना उचित है। अतः वन सरंक्षण अधिनियम 1980 के तहत भू—हस्तांत्रण की प्रकिया अगामी कार्यवाही के लिए प्रेषित की जाती है।

On the subject cited matter this office is in receipt of letter No. Ft.48-3785/2018 (FCA). dated 24.7.2021 from Nodal Officer.Cum-APCCF (FCA) office of Pr. CCF (HoFF) H.P. vide which it has been informed that the MOEF has observed as under:-

"The concern of the State to provide for mitigating measures of individual projects in the EMP does not seem to be tenable as it is devoid of factual basis. The hydel projects up to 25 MW are not covered under the EIA notifications and hence may not involve preparation of EMPs and also cannot be appraised by the SEAC as adverted by the State. The State Govt. may provide their comments in this regard."

In this context it is submitted that as per point No. 2 and point No.4 (iii) of the notification dated 14<sup>th</sup> September 2006 of Ministry of Environment and Forests (MoEF), State Environment Authority (SEIAA) is authorized to give environmental clearance for projects put in Category-B in the schedule. Perusal of schedule reveals that no environment clearance is required for the projects upto 25 MW. This fact has also been clarified vide letter No. STE-F (1) 3/2017 dated 14.6.2017 of Spl. Secretary (Env. Science & Technology) to the

Govt of H.P. (copy enclosed). This letter also mentioned that as these projects are of white category hence there is no need for such projects to undergo for consent mechanism, from EIA, therefore no cost on EMP is to be levied. Therefore in view of above, no EIA & EMP is required in respect of the projects upto 25MW.

As the issue involves projects upto 25 MW, and the comments have been sought from Government, therefore, further comments be forwarded to the quarter concerned at the lever of Directorate of Energy on behalf of the State Government.

Issues pertain to hydro power projects up to 25 MW in the State.

Madam/Sir,

I am directed to refer to the subject captioned above and to say that the matter with regard to consent to operate for the projects up to 25 MW was engaging the attention of the Government for some time past since the hydel projects up to 25 MW have been declared as white category project by the GoI, hence there is no need for such HEP (up to 25 MW) to undergo consent mechanism under Water/Air Act and also to obtain Environmental Clearance from SELAA.

Further, no Environmental Management Plan (EMP) cost be levied on HEP (up to 25 MW) as these are not required to undergo EIA mechanism.

You are, therefore requested to take further necessary action in the matter under intimation to this department.
