Vide reference 11th cited, the Integrated Regional Office, Gol, MoEF&CC, Hyderabad has informed that the ministry vide letter dated 18.07.2022 has issued instructions regarding deciding on the applicability of FC Rules, 2022 to the proposals already under process. Further, as per the instructions, the proposals received from the State Government on Parivesh portal have been examined and as the subject proposal was accepted by the Nodal Officer on or after 28.06.2022 online, returned the proposals to process as per the provisions of Forest (Conservation) Rules, 2022 and accordingly instructions issued to the UA to upload the proposal in parivesh 2.0.

Now, Vide ref 13th cited, the UA has uploaded the proposal in parivesh 2.0 and parivesh 2.0 has some issues while uploading the data-at DFO and could not be processed further.

In this regard, it is submitted that vide ref 14th cited, the GoI, MoEF & CC, New Delhi has issued guideline on processing of the proposals at point no.3(iii) it has been mentioned that the " Proposals, already submitted in the PARIVESH 2.0 at various levels, may be processed in offline mode by the processing authorities of the State/UT concerned following the statutory process provided in the Forest (Conservation) Rules, 2022." at point no.3(iv) it has been mentioned that the "After rolling out of complete functionalities of the FC modules on PARIVESH File No.FC-11/118/2021-FC 2.0, as envisaged in the Forest (Conservation) Rules, 2022, details of proposals processed in offline mode, as indicated under para 3 (iii) above, will be updated in the PARIVESH 2.0 by the authorities/user agency concerned"

In view of the above, the Regional Officer, IRO, Hyderabad is requested to process the proposal in offline mode as per the guidelines issued on 14.11.2022. Further, the details of Part-II, Part-IV , Part-V will be updated in portal as and when the issues are resolved in parivesh 2.0.
