

Sanction Order of the Site Specific Wildlife Management Plan with reference to the diversion of 10.106 ha (7.101 ha notified forest land and 3.005 ha Jangal-Jhari) of forest land in favour of Damodar Valley Corporation (DVC), Hazaribag for construction of 132 KV D/C Hazaribagh (Sindhur) Substation of DVC to TSS of East Central Railway, Dhanbad Transmission Line under Hazaribagh West Forest Division in Hazaribagh district of Jharkhand.

The instant Site Specific Wildlife Management Plan for Conservation of Flora and Fauna (referred to as “*the Plan*” or “*WMP*” hereinafter) has been submitted by Damodar Valley Corporation (DVC), (referred to as “the User Agency” or “DVC” hereinafter) in compliance of the Condition laid under Item no. i of the approval order issued by the Ministry of Environment, Forest & Climate Change, Government of India, Regional Office, Ranchi vide its letter no. FP/JH/TRANS/120412/2021/293 dated 09.05.2024 for diversion of 10.106 4ha (1.101 ha notified forest land and 3.005 ha Jangal-Jhari) of forest land for construction of 132 KV/DC Transmission Line from Hazaribagh (Sindhur) Substation of DVC to TSS of East Central Railway, Dhanbad passes through the villages- Churchu, Nagwana, Merawal, Nawdiha, Mandaikhurd, Maiakalam, Alagdiha, Harina, Mayapur, Chharwa, Godokhar, Luta Salgawan, Kadma and Rewali.

The aforesaid condition laid by the Central Government read as follows:

“i. The committee demanded a comprehensive Wildlife Management Plan for the proposal for further consideration.”

In the above stated background, the User Agency and DFO Hazaribagh West in pursuance of complying the aforesaid condition laid by the Central Government, have prepared the instant Plan in consultation with each other. Vide his letter no 870 dated 07.05.2025 the Regional Chief Conservator of Forests, Hazaribagh submitted the plan to the office of the undersigned for its due sanction. In order to examine the plan prescriptions a communication was issued to the Regional Chief Conservator of Forests, Hazaribagh, vide this office letter no. 944 dated 20.08.2025, to arrange a Power-Point Presentation of the plan on 22.08.2025 in the Office chamber of the undersigned.

While considering the plan for its approval, a Power Point Presentation was scheduled with CF, Hazaribag, DFO, Social Forestry, Ranchi, DFO, Hazaribag West, DFO, Wildlife Division, Ranchi, Sri R.S Sharma, Sr. G.M, DVC, Hazaribagh and Sri R.K. Tudu, Sr. Manager, DVC, Hazaribagh in the office of undersigned. During the PPT certain observations were made and DFO, Hazaribagh (West) was instructed to modify the plan on certain points. Compliance of observations made by undersigned was submitted by the DFO, Hazaribag (West) vide his letter no. 4850 dated 06.10.2025.

The Plan contains six chapters including 1)Introduction and Background, 2) Potential impact due to the project and its quantification, 3) Management objective and mitigation strategies, 4) Intervention to be done by the User Agency, 5) Interventions to be done by Department through DFO, 6) Maps and budget estimate. Wildlife management plan suggests "Mitigation Measures" to the actions that can be implemented to minimize the magnitude of the project related detrimental impacts on ecology in general and forest & wildlife of the project area. The various work components have been assigned to the implementing agencies so as to achieve the maximum efficiency in terms of output and to address the needs of conservation of forests and wildlife.

The cost of the proposed 10 years Wildlife Management Plan with respect to the activities to be carried out by DFO, Hazaribag West Forest Division has been estimated to be Rs. 279.43 lakh. In addition to it certain activities shall be undertaken by the user agency in consultation with DFO, Hazaribagh west Forest Division the details of which have been enumerated in Part A. The summary of the proposed interventions (component wise) under the Plan with the objective of conservation of forest and wildlife resources is as follows:



The Plan with a total financial outlay of Rs 279.43 lakh for implementation of Wildlife Management Plan (WMP) extending over a period of 10 years (Year 2025-26 to 2035-36; tentatively), shall be utilized by the State Forest Department through the DFO, Hazaribag West Forest Division in accordance with the Plan prescriptions.

Considering the proposals under the plan, sanction is hereby accorded to the instant Plan subject to the following conditions:

- (i) Implementation of the Wildlife Mitigation Plan prepared in respect of the proposed project.
- (ii) That various activities in the project shall be executed under the monitoring and guidance of DFO, Hazaribag West in their respective jurisdiction and under the supervision of RCCF Hazaribag, CF, Territorial Circle Hazaribag and CF, Territorial Circle Chatra.

- (iii) That the User Agency shall ensure that its officials/contractors and the work force engaged into transmission line laying and allied works shall not commit or abet any forest/wildlife offence in their area of operation. They will also promptly report any forest/wildlife offence in the area to the nearest forest office/official. Further, they will extend their full cooperation to the forest officials in control/mitigation of any incident, natural or manmade, detrimental to forest and wildlife in their area of operation.
- (iv) In the cases of management of lands of Protected Areas/forests under transmission lines will be followed while implementing of the project and with special considerations for protecting elephants from accidental electrocution by keeping height above ground at the lowest point of the lowest conductor or grounding wires (i.e. at maximum sag point) of power lines and also to avoid electrocution to avifauna and other arboreal species.
- (v) The entire length of the proposed power line between Hazaribagh (Sindhur) Substation of DVC to TSS of East Central Railway, Dhanbad should be marked with appropriate bird diverters spaced at 10 m intervals. The bird diverters shall be regularly checked and maintained by the User Agency.
- (vi) The user agency and project personnel will comply with the provisions of Standard SOP/Guidelines issued by WII, Dehradun for linear projects.
- (vii) Any felling/pollarding/pruning of trees for allowing electrical clearance/maintenance will be done with the permission of the DFO, Hazaribagh West in their respective jurisdictions. Only those trees that are of sufficient height to compromise the requirements of minimal vertical and horizontal clearance from the conductor wires at maximum sag point should be lopped.
- (viii) The gabion plantation of native, palatable species suitable for wild ungulates should be actively promoted by the user agency in collaboration with Jharkhand Forest Department below the power-line in order to avoid invasive species likely to come up due to periodic clearing of vegetation along the power-line.

- (ix) That the amount of Rs. 279.43 lakh shall be deposited by the User Agency into CAMPA account only through <https://parivesh.nic.in> under the relevant head/sub-head which shall be utilized by the State Forest Department through the DFO, Hazaribag West as delineated under the Plan, strictly in accordance with the prevailing norms under the Jharkhand Forest Department.
- (x) That the User Agency shall implement the mitigation measures/activities mentioned under the Plan. The implementation shall be done under the directions and strict supervisions of DFO, Hazaribag West.
- (xi) That the DFO, Hazaribag West shall prepare detailed Annual Plans of Operations (APOs) in the beginning of every financial year during the Plan period, as provided in the instant Plan, following all the rules, regulations, Schedule of Rates etc. issued from time to time by the State Government/ Forest Department. RCCF, Hazaribag in case of DFO, Hazaribag West shall accord sanctions to the said APOs following due process and they will respectively closely monitor the implementation/progress of the activities undertaken by Hazaribag West Forest Division as per directions issued by the Forest Department from time to time.
- (xii) That the CF, Hazaribag shall supervise all the activities under the Plan undertaken by Hazaribag West Forest Division as per directions issued by the Forest Department from time to time.
- (xiii) That the DFO, Hazaribag West shall carry out the activities under the Plan strictly as per the duly sanctioned APOs.
- (xiv) That the DFO, Hazaribag West shall ensure that no violation of duly sanctioned Working Plan of Hazaribag West Forest Division takes place during implementation of any of the activities involved in this plan over notified and demarcated forest land.
- (xv) That the instant Plan is dynamic and shall be revisited after every 2 years and a revised plan may be formulated as per need of the project impacted area and convenience of the implementing agencies. The revised plan, if any, shall be put up before the Principal Chief Conservator of Forests, Wildlife & Chief Wildlife Warden, Jharkhand for its due approval.

(xvi) That the User Agency shall submit an Undertaking to the DFO, Hazaribag West to the effect that they will deposit extra cost of the plan owing to increase in wage rate, cost of materials etc. in due course of time as well as consequent upon revision of the plan, if any, as and when given effect to by the competent authority.
