It is submitted that no separate structure shall be constructed like Sumps, OHBRS, GLBRs etc., the pipeline will only be laid with some pipe supporting structures like Thrust Blocks, Pedestals, Anchor Blocks and Value Chambers which are part of the construction of pipeline only. The above blocks and valve chambers shall be constructed within the 2.50 m width of pipeline proposed (total area is within 1.345 Ha. only) and no additional area is required. The User Agency has submitted map showing DGPS co-ordinates (points 1 to 64) of the pipe supporting structures.

# AGREEMENT FOR PROVISION OF WAY LEAVE /EASEMENT RIGHTS ON RAILWAY LAND AS PER WAY LEAVE FACILITY TO OUT SIDE PARTIES.

Memorandum of agreement is made at Secunderabad this 7th day of August 2018 between the President of India acting through the Sr.DEN/North/SC of South Central Railway Secunderabad. here in after called the administration (which expression shall include his successors/legal representatives and assignces etc) on one part and the Executive Engineer/TDWSP Division, Peddapalli, Telangana. Here in after called the applicant (which expression shall include his successors/legal representatives and assignces etc) on the other part.

Whereby it is agreed as follows:

- 1. The applicant shall have the use of the piece of Railway land described in the schedule here under written and delineated on the plan No. DRM/(W) SC/BR/103/2018 is attached here to and thereon colored here in after called the said land for the purpose of way leave/easement rights on railway land.
- 2. It is an essential condition that this permission is given on the express understanding that the said land shall be used solely for way leave/ easement facilities and that the use of the said land for any other purposes or conveniences thereon shall constitute a breach of this agreement and render it liable to immediate cancellation without notice.
- 3. Should the applicant find it necessary to lay down pipe line for the conveyance of laying of 750mm dia. M.S water supply carrier pipe line crossing through 1000mm dia. MS easing pipe by horizontal boring method under railway track at km 280/2-4 between RDM -RGPM Stations in the railway area of the said land for the Permission for laying drinking water pipe line between RDM-RGPM stations on BPQ-KZJ section for providing water supply to the Ramagundam Fertilizer & Chemical limited (RFCL) from Ramagudam from Yellampally project installation the railway land required for the said water pipe line will be demised to the applicant a nominal width of as shown in the enclosed plan. Being taken when calculating the area occupied by such Drinking water pipe line which area shall be entered in the schedule. Applicant's pipes must be laid underground and in such manner that wheeled vehicles can pass over them and no claim will be made by the applicant for any damage which may occur owing to vehicles passing over them. The surface land may be used by the administration or may be permitted to be used for any purpose and the applicant shall not be entitled to make any objection or claim any compensation on that account.

In the event of the way leave facility being terminated the conditions embodied in clause 2 there of shall apply to Executive Engineer/TDWSP Division, Peddapalli, Telangana State, thereto.

- The applicant shall allow the General Manager or other officers of the South Central Railway. authorized in that behalf free access at all times to the said land whether completed or in the course of construction and the applicant shall whenever so requested by the said general manager of the aforementioned officer forth with pull down, rebuild, replace or repair any part of such works conveniences which the said general manager or the authorized officer may consider to be improperly saturated or of defective construction or materials or in want of repair.
- The applicant shall have to pay the administration through Sr. Divisional Limited manager Secunderabad, South Central Banway an amount of Rs.76,247/-towards way leave charges. Rs.4.12.244/- for Departmental charges and Rs.87.928/-for Service/Tax for 10 years. 1 oral cost Rs.5.76.419 . Total amount of Rs.5.76.419% has been paid by party i.e. for a value

The way leave charges are worked out based on Board's instructions from time to time. The way leave charges are recovered for the period of 10 years subject to minimum amount and rates mentioned in Board's letter No.97/LML/24/3, Dt. 27-11-2001 and CGE/SC letter No.W.417/ST/Central Excise/W-17, dt.6.6.2013 and revised from time to time. Annual increase of 7% of land value shall be assumed in cases mentioned in Board's letter. The amount to be paid in advance is discounted in cases mentioned in Board's letter based on interest rate announced by RBI for Govt. securities. The rate of interest to be adopted is 6.61% p.a.

A. Maintenance Charges.

- 1. Encased pipeline crossings provided as per stipulation of BS No.105 of October 2009 are being treated as track crossings and not as normal bridges. Hence, no maintenance charges are being collected at the time of execution of agreement. However, the agency sponsoring the pipeline facility and party to this agreement, will pay in advance the amount specifically demanded by Railway authority i.e. DEN/Sr.DEN of the division duly vetted by Associate Finance, once in a year to cover the maintenance requirements
- 2. In addition, the agency should cover all damages including consequential damages because of laying pipeline in the Railway area and any amount actually spent and demanded by Railways in this regard should be arranged expeditiously by the Agency sponsoring the pipeline/the party to this agreement.
- 3. Failure to comply with the above stipulations within one month or so, Railways will resort to cancellation of permission granted and stoppage of facility without any further
- B. The applicant shall not be entitled to assign, mortgage, sublet or transfer otherwise the privileges mentioned in clause I hereof without obtaining the consent in writing of the administration. In the event of the breach by the applicant of any of the terms or conditions herein contained all privileges conferred under this way leave facility shall absolutely cease and determine immediately and the applicant shall not be entitled to any compensation
- Cl The said privileges mentioned in clause I thereof are granted on the express condition that either party will be at liberty to determine and put and end to this way leave facility without assigning any reasons by giving to the other party at any time three calendar months notice in writing and after the expiry of the said period such privilege may be so determined by the administration to use and shall yield and deliver up to the administration the said land.
- D. Nothing there in contained shall be construed to create a tenancy in favour of the applicant of the said land or to prejudice or affect the rights and powers of the administration in and over and in relation to the said land and the use and enjoyment thereof and the exercise by the applicant of the liberties and way leave facility here by granted shall in all respects be subject to the control of the administration which shall have full and absolute power from time to time to direct in what manner such liberties and way leave facilities shall be exercised and enjoyed by the applicant and as the administration shall from time to time direct not to do or suffer cause to be done or suffer in relation to the exercise of the said liberties and way leave facility anything that may be unisance to the neighbor hood or dangerous to the adjoining premises or the seixailt or agent of the administration or to any other person. All instructions given by the administration under this clause will be carried out by their applicant,
