In this connection a number of meetings organized by Forst office in their building/VC have been attended by CPWD officials. Several observations/paras/queries raised via forest office were communicated to CPWD time to time and CPWD had put efforts to resolve those paras under able guidances & satisfaction of Forest office. The matters related to joint site verifications, mismatching of shape file, preparation of final shape file in consultation with the TSCST, GIS lab report, cost-benefit analysis, preparation/arrangements of required layout plans, land statements, preparation/arrangements of several undertakings needed for forest clearance, preparatory phase of forest clearance proposal and all that has been taken care by the CPWD under the guidance of forest department and several communication are available in this connection. Although due to global deadly pandemic (COVID) and imposition of nationwide lockdown & nonopening of Govt. offices during the year 2020 and 2021, above process got hampered badly, instead of such beyond "human controlled obstacles" and being a comlicated case with something very uncommon for CPWD, on the one hand CPWD pursued for the case/forest clearance proposal with the Forest department & other associated departments/agencies etc. in addition to attention towards the execution of running Govt. prestigious projects scattered all over in Tripura state, on the other hand.

Further as the said land in question was purchased for the construction of "General pool residential accommodation (GPRA)" for the Central Govt. employees posted in Tripura so construction of residential quarters & associated mandatory utilities for functioning of buildings (on previously purchased & broken land with no fresh breaking of land) was carried out within boundary of GPRA colony so as to provide the accommodation facilities to Central Govt.employees working in several Central Govt. departments and to Govt. engineers & staff of CPWD as well, who had been deployed (after getting transferred from others regions of India) on several prestigious projects in Tripura state. In fact on the one hand, it helped CPWD to complete the several projects of national importance located all over in Tripura state and on the other hand, loss of Govt. revenue has been reduced due to allottment of constructed residenatial quarters in GPRA colony in public interest but after the final judgement passed by Hon'ble NGT in November 2017 no any such construction related tenders have been called by the CPWD. It is mentioned that chronology of all the events (that included construction of GPRA part also) was already submitted by CPWD vide our letter No. NGT (GPRA)/TCD-I/AGT/2022/2011 dated 21.11.2022 sent to your good office.
