Name of Project: - Diversion of 0.020 Hectare Forest Land for Laying of underground OFC cable in forest area in Ajmer city along road from lat/long point 26.42448/74.61972 to 26.42630/74.62239 for total length of 0.444km and forest area 0.0200 ha, within ROW limits of the road in Ajmer District, Rajasthan. FP/RJ/OFC/47299/2020.

A proposal has been received by this office from **JIO DIGITAL Fiber private limited** for diversion (under FCA-1980) of **0.020 Hectare** Forest Land for Laying of underground OFC cable in forest area in Ajmer city along road from lat/long point 26.42448/74.61972 to 26.42630/74.62239 for total length of 0.444km and forest area 0.0200 ha, within ROW limits of the road in ajmer District, Rajasthan. FP/RJ/OFC/47299/2020. Forest Land to be diverted 0.020 hectare of forest land for non forestry purpose. The subject envisages the use of forest land for Laying of underground OFC cable in forest area in Ajmer city along road from lat/long point 26.42448/74.61972 to 26.42630/74.62239 for total length of 0.444km and forest area 0.0200 ha, within ROW limits of the road in ajmer District, Rajasthan.
