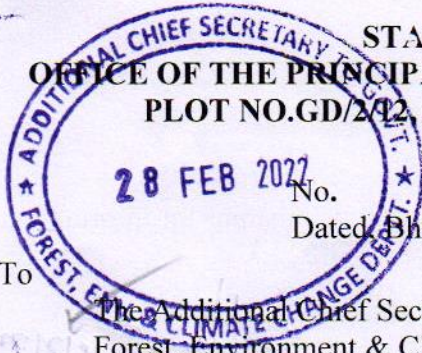

Madam,

In reference to the letter cited above on the captioned subject, compliances to the clarifications on the observation made by GoI, MoEF & CC, IRO, Bhubaneswar on the said proposal are submitted as below.

1. ***On examination of KML file in DSS, the area identified for CA over 5.664 ha of degraded revenue forest land is encroached by human settlement.***

The CA land demarcated by the revenue officials is only of 14 acre = 5.664 ha out of the total area of 55.19 acre (in 2 nos. of plots) having kissam Patra Jungle and Bada Jungle of revenue forest land. The identified demarcated CA land (5.664 ha) is free from encroachment and encumbrance and not having any structure, this has been authenticated by the Tahasildar, Lakhanpur Tahasil of Jharsuguda district enclosed as **Annexure-A**. Additionally, the rectified KML file of the CA land has been uploaded in Parivesh web portal and soft copy is enclosed in CD format.

2. ***Copy of CA scheme is not uploaded in Parivesh web portal of the Ministry.***



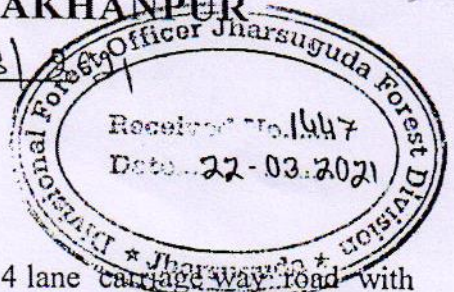


