The report of the Deputy Conservator of Forests, Sirsi and compliance of User Agency in three (3) sets is enclosed herewith for your kind information and needful action.

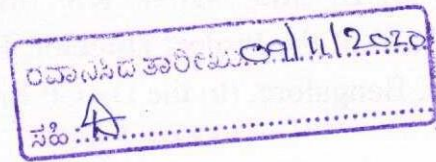


