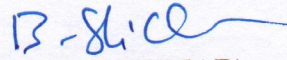

With reference to the above proposal seeking Stage-I approval submitted by this office vide Ref (1) letter dated 21-10-2022 and by the Government of Karnataka vide Ref (2) letter dated 14-11-2022, the Government of India vide Ref (3) has raised an EDS Query seeking certain additional information. The same has been communicated by the Government of Karnataka vide Ref (2) letter dated 16-12-2022 to this office. Accordingly, this office vide Ref (1) letter dated 28-12-2022 has forwarded the same to the field officers and further to User Agency.

In response, the User Agency vide Ref (4) has submitted the information sought by the Government of India, that has been forwarded to this office through FC web portal by the field officers vide Ref (5)&(6).

Based on the reply furnished by the User Agency and the information available in the proposal, the following reply is submitted to the query raised by Government of India.

Government of India Query	Reply
1 The State Government has identified 38.00 ha of degraded forest land for raising the Compensatory Afforestation in Sy. No. 48,50 & 94 of Haniya and Sy. No. 27 and 65 Harthalu village of Hosanagara taluk, Shivamogga District. In this regard, it may be clarified whether the present project is a Central Government project being executed by the State Government or it is purely State Government Project. If the project is of Central Government project being executed by the State Government, then the name of the user agency may be entered as MoRTH/Central Government agencies in the FORM-A of the application in PARIVESH portal as per Ministry guideline No.FC-11/50/2020-FC dated 18th August, 2020. Further it may be seen that for State sector projects, the user agency has to provide equivalent extent of non-forest land for raising the Compensatory Afforestation.	The proposed project is a Government of India, Ministry of Road Transport & Highways (MoRTH) project being implemented by State Government, Public Works Department. The User Agency has furnished the sanction letter F. No. NH-12014/15/2022/KNT/South-I dated 14-10-2022 from MoRTH which is enclosed herewith.
2 The KML file has been uploaded for the entire stretch of the proposed road. Therefore, KML file of the forest area proposed for diversion may be uploaded in PARIVESH.	The KML file of the proposed forest land for diversion is uploaded in Part-I of Parivesh web portal.
3 It is seen that 2.902 ha of forest land proposed for diversion has been leased to	Out of 18.844 Ha of forest land proposed for diversion, 2.902 Ha of

	Mysore Paper Mills limited. Hence, NOC from Mysore Papers Mills Limited may be furnished for diversion of said portion of forest land. It may also be noted that the proposed road is passing through the backwater of Linganamakki Reservoir as per satellite imagery. Hence, NOC from Authorities of Linganamakki Reservoir may be obtained, if the said stretch of road falls in forest land.	forest land is found to be leased to Mysore Paper Mills Ltd. Bhadravathi. The User Agency has furnished the No Objection Certificate No. MPM/FFR/DF/2023-24/012 dated 30-06-2023 from Mysore Paper Mills Ltd. Bhadravathi which is enclosed herewith. Further, User Agency has also furnished the No Objection Certificate No. CECS/K/NH766C/NOC/1478 dated 24-01-2023 from Karnataka Power Corporation Limited, Kargali which is enclosed herewith.
4	The comments/approval of CWLW on the mitigation plan proposed by DCF, Sagar may be furnished.	The Mitigation Measures proposed by DCF, Sagar is approved by Principal Chief Conservator of Forests (Wildlife) & Chief Wildlife Warden, Karnataka vide Ref (7) and is enclosed herewith.
5	It may also be clarified whether the forest land proposed for diversion is part of notified ESZ or otherwise.	DCF, Sagar vide Ref (5) has reported that the forest land proposed for diversion does not fall within the limits of notified ESZ.

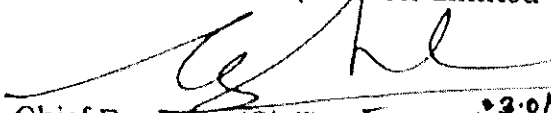
The aforesaid NOC to carry out the intended project is issued subject to following terms and conditions;

1. The reservoir water shall not be polluted during the course of execution.
2. The flow of water shall not be obstructed at any time during the course of execution.
3. The excavated materials shall be disposed off to a safe place away from MWL of the reservoir and shall not be dumped into the reservoir basin.
4. Blasting of hard rock and quarrying of sand in the reservoir basin is strictly prohibited.
5. Care shall be taken to protect the reservoir basin from any accidents/incidents during the course of execution of work.
6. Executive Engineer, National Highways, Shivamogga is fully responsible for any damage caused to the reservoir basin during execution of the project.
7. Fishery activities if any shall not be carried out by the staff of the concerned agency and authority.
8. Statutory clearance/ NOCs required for the execution of intended project shall be obtained from the concerned departments like Forest, Revenue, etc., and including Inland Water ways apart from concurrence of KPCL.
