Subject: Diversion of 174.652 (Third) revised (1st revised area: 181.153 ha, 2nd revised area: 173.703 ha and 1st proposed area: 177.091 ha) hectare of Forest land in Dharwad, Haliyal, Dandeli Wildlife and Belagavi forest divisions for laying of Goa-Tamnar 400 KV D/C Quad Transmission line (LILO Project) in favour Of Manager, Goa-Transmission Project Limited.

With reference to the above-mentioned subject, some additional forest areas were encountered in line alignment, which was not considered in earlier submitted proposal so that User Agency have requested to verify on the ground under ref (1). After the careful verification on the ground some additional forest areas were encountered in line alignment, therefore User Agency has directed to reverify the proposal and submit the revised proposal through Fc web portal according to the procedure of Forest (Conservation) Act

1980 under ref (2) and EDS also raised through online under ref (3) and (4) dated 5.6-2023.

After that User agency has submitted first time revised (1st revised total area: 181.153 ha) proposal under ref (5) dated 10-07-2023 and UA has again resubmitted second time revised (2nd revised total area: 173.703 ha) proposal under ref (5) dated: 25-08-2023 and EDS reply also submitted through online under ref (6) dated: 18-08-2023.

After the careful consideration of the project, User agency have submitted revised forest area of the proposal differently each time, therefore User Agency was directed to reverify the proposal and submit the correct revised proposal through Fc web portal under ref (4) dated 14.9-2023 (Online EDS Raised). UA has again resubmitted Third time revised (3rd revised total area: 174.652 ha) proposal under ref (5) dated: 18-09-2023 and EDS reply also submitted through online under ref (6) dated: 18-09-2023 and have requested to consider this below 3rd revised proposal.

During the inspection of revised forest area 7.758 ha (1st proposed forest area 4.786 ha and additional forest area 2.972 ha) of Dharwad division proposed for Goa-Tamnar 400 KV D/C Quad Transmission line (LILO Project) passing through Reserve Forest area by undersigned on 07-10-2023 the following points were observed.

The present revised project of Goa-Tamnar 400 KV D/C Quad Transmission line (LILO Project) passes through in Dharwad District in the different reserve forest area falling under jurisdiction of Dharwad Ranges of Dharwad Forest Division. The village wise details of the forest areas proposed to be diverted is as follows:

- No Rare/endangered/RET/Unique Species are found in the proposed area.
- No Wildlife/ Corridor activities are going in and around the proposed area.
- Proposed area does not fall under any Archaeological/Heritage site/defence establishment or any other important monument of protected area.
- Proposed area does not fall under any Eco Sensitive Zone (ESZ) of the protected area.
- The diversion Proposal involve/ will lead to felling of 2301 number of trees of mixed Species like Tectona grandis, Acacia, Eucalyptus, etc..... (Copy Attached – Annexure-1) and Spotted deer, Barking Deer, Jackal, Hare, Pangolin, Wild boar, Porcupine, Civet cat, rock python Peacock Russel's viper, Wood packer, Hornbill, Owls, Kingfisher, Fly catcher, etc.....Fauna's found in proposed area.
- Degraded forest land details as proposed for Compensatory Afforestation in lieu of earlier/old proposal is only for 10 ha in Mandihal Reserve Forest Sy No's 34,36,37,38,44 of Mandihal section of Dharwad range. As per field verification the above areas are already afforested under State budget scheme, therefore an alternative Degraded Forest land for Compensatory Afforestation in lieu of revised proposal equal to 16 ha in Sy No 20,24,25,26,37,39 of Varav-Nagalvi village of Mandihal Section of Dharwad range was inspected by undersigned on 07-10-2023 and recommended also, (Attached DGPS maps, Topo maps, CA Suitability Certificate, CA scheme details of 5-Sets).

Diversion of revised forest land 7.758 ha of Dharwad Forest division as proposed by the User Agency is unavoidable and bare minimum of requirements. Hence proposal may be recommended for the 7.758 ha forest land area of Dharwad Forest division for the Diversion of 174.652 (Total) hectare of Forest land in Dharwad, Haliyal, Dandeli Wildlife and Belagavi forest divisions for laying of Goa-Tamnar 400 KV D/C Quad Transmission line (LILO Project) (Proposoal NO: FP/KA/TRANS/37754/2018) as per the provisions prescribed in section 2 of Forest (Conservation) Act-1980.

Needful corrections have been incorporated wherever necessary by User Agency and undersigned, Hence I am here by submitting with other necessary documents from Dharwad division side of the revised proposal (4 sets of hard copies received from User agency and 5 sets of CA scheme Details, Toposheet and DGPS maps of CA land, CA suitability certificate of Revised proposal.) for your kind needful action.

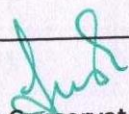
