Further, as reported by DFO the project site falls within the Kameng Elephant Reserve, notified vide CWL/D/T/2001 dated 19.06.2002. Since elephant movement has been reported in the area, the user agency is advised to submit a comprehensive Wildlife Mitigation Plan to address potential impacts on elephants and other wildlife.

It is therefore, requested to kindly issue necessary In-principal approval for diversion of 0.5336 ha forest land for construction of above transmission line under Section-2 of the Van (Sanrakshan Evam Samvardhan) Adhiniyam, 1980

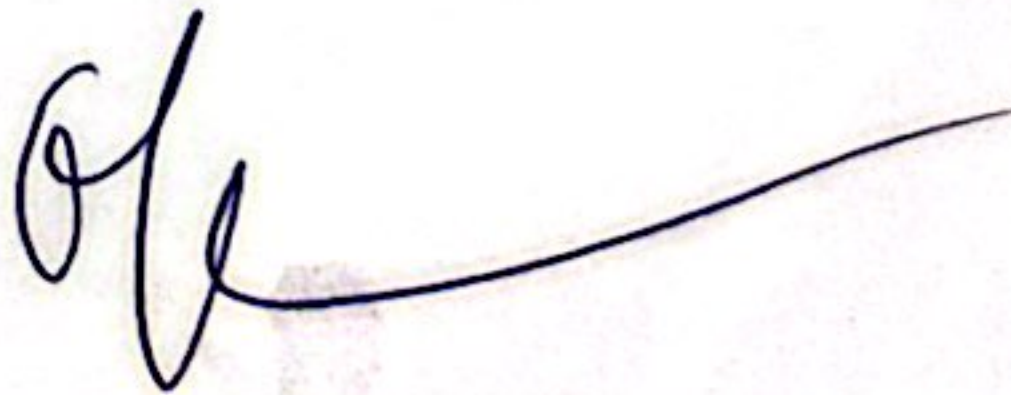
Sir,

Please refer to above letter on the subject. In this regard, it is submitted that as per 2011 guidelines issued by the Ministry of Environment, Forest and Climate Change for Eco-Sensitive zones, the erection of Cables is not prohibited activity. Further, the Ministry vide letter dated 17.05.2022 clarified that regulated and other activities proposed within notified ESZ around the National Park or Sanctuary shall require consideration by NBWL/SCNBWL, if such activity is covered under the Schedule of EIA Notification, 2006. The instant proposal does not attract the provisions of EIA Notification, 2006. Therefore, Wildlife Clearance of the instant project may not be required.

However, in light of Apex Court direction dated 03.06.2022 in IA 1000 of 2003 in the matter of WP (202)/1995, you have requested for obtaining Wildlife clearance. It is not clear whether only Wildlife clearance is required or permission of Apex Court will also be required in the subject matter.

In view of above, you are requested to convey your decision on the above matter for further necessary action from this end.

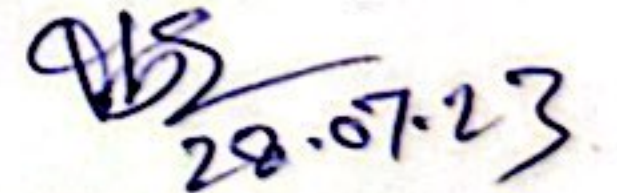

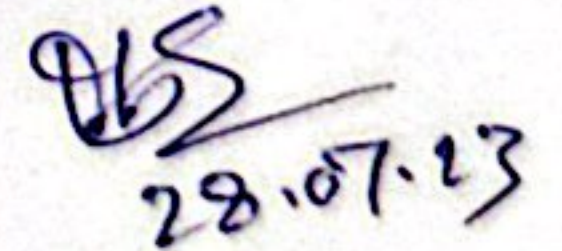
