

- The Deputy Director, Srivilliputhur Megamalai Tiger Reserve, Megamalai Division, Theni should be ensured that animal crossing points are maintained with reference to small mammals as well as big animals, by avoiding continuous fencing
- The Deputy Director, Srivilliputhur Megamalai Tiger Reserve, Megamalai Division, Theni to obtain an undertaking from the user agency regarding the amount of Rs. 62.51 lakhs will not be claimed in future in any case.
- The Deputy Director, Srivilliputhur Megamalai Tiger Reserve, Megamalai Division, Theni should submit the progress report on monthly basis till the works are completed and also submit the work completion report along with Geo tagged images.
