3. **FRA 2006**

The user agency has furnished FRA certificate for 5.669 ha of Reserve Forest duly
obtained from the Collector and District Magistrate, Mayurbhanj, which has been submitted to the Field
Director, Similipal Tiger Reserve-cum- Regional Chief Conservator of Forests, Baripada vide his letter No.
2089 dt.20.07.2016 (Xerox copy enclosed).

4. **CA Land**

- The Tahasildar, Gopabandhu Nagar (for Daundia) and Jamda (for Gohira) have reported that the
process for de-reservation of Gochar land is under progress (xerox copy is enclosed).
- The scheme for block plantation in Baripada and Rairangpur Forest Division has been re-casted for 10
years maintenance and has been re-submitted.
