Sir,

On the subject and references cited above, it is to inform your good self that in light of the EDS raised by the Integrated Regional Office, MoEF&CC Jammu's File No. 9-JKB-011/2022-Jammu Dated: 17.06.2022, the user agency have reduced the length of the proposed road from 6 Kms to 5 Kms which is now in keeping with the length mentioned in the DPR. The user agency have made the corresponding corrections in the KML file uploaded on PARIVESH.

However, as per the communication received from the user agency vide No. 5146-47 Dated: 04.08.2022 (copy enclosed), they have expressed the concern that due to technical reason, they are unable to make the necessary corrections in the extent of forest area proposed for diversion in Part-1 (Form-A) which has now reduced from the proposed 2.5453 Ha to 1.505 Ha.

In view of the above, the user agency have already made a request to the Chief Conservator of Forests, Nodal Officer (FCA) for allowing them to make necessary corrections in Part-1 (Form-A) on PARIVESH portal. Hence, it is requested that the case may kindly be forwarded to the Chief Conservator of Forests, Nodal Officer (FCA) for effecting the necessary changes in the Part-1 (Form-A) w.r.t change in proposed area at the earliest please.

With the content of above noted subject and proposal IRTO Jammu has raised EDs that the stretch of 6.00 km road of proposed road is not plausible in absence of written approval of 6.00 km of road.

Now as per EDs and DPR we have reduced the length of the proposed from 6.00 km to 5.00 km (in the KML file) as a result of which the Forest area has been reduced from 2.5453 hac to 1.505 hac. We are trying to make an amendment /recast in Form-A Part-I in the Parivesh Portal with report of the Forest area but not able to modify the same as the edit option is not working.

It is as such requested to your goodself kindly allow to make necessary amendment for the same in Form-A Part-I of Parivesh Portal.
