Vide ref 33<sup>th</sup> cited, the GoI, MoEF & CC (FC Divn), New Delhi has sought for additional information on the subject proposal.

Accordingly, vide ref 35<sup>th</sup> cited, the General Manager, Kothagudem area, SCCL, Kothagudem District has furnished information as desired by the Gol, MoEF & CC, New Delhi which are furnished as follows, with remarks:

**Point No.1:-** The IRO shall analyze the C:B ratio study report and the Biodiversity report submitted and offer its comments in this regard.

**Reply:-** The copies of Cost Benefit analysis study report prepared by IIFM, Bhopal and Bio-diversity Study prepared by EPTRI, Hyderabad, were submitted by the SCCL to the Integrated Regional Officer, MoEF&CC, Hyderabad, vide letter ADF/SCCL/HYD-J6, Dt. 05.06.2023.

**Point No.2:-**The State Govt. shall provide information with regard to wildlife conservation and mitigation plan namely (i) who has prepared the plan and (ii) who has verified the details of the plan.

**Reply:-** The wildlife conservation and mitigation study was conducted and plan prepared by Environment, Protection, Training and Research Institute (EPTRI) which is an Autonomous Body of the State Government based at Hyderabad. The wildlife conservation and mitigation plan was analyzed by the field officers at level of District Forest Officer, Bhadradri Kothagudem District and CCF/ Conservator of Forest Officer, Bhadradri Circle. The plan was recommended by the Conservator of Forests in Rc. No. 5694/2021/WL-1, dt. 12.10.2021. In the said plan wildlife mitigation activities were recommended at a cost of Rs.478.60 lakh with components like development of water sources, improvement of habitat, strengthening protection, capacity building and awareness among front line staff and local communities, machinery and equipment, monitoring and research, publicity and office support. The mitigation plan

was approved by Chief Wildlife Warden, Telangana in Rc. No. 5694/2021/WL-1, dt. 12.10.2021 to be implemented over a period of 5 years. The said mitigation amount of Rs.478.60 lakh was deposited in the Biodiversity Conservation Society of Telangana (BIOSOT) account of Chief Wildlife Warden, Telangana on 20.03.2022.

**Point No.3:-**The State Govt. shall clarify whether in view of the submitted Biodiversity Report, the wildlife conservation and mitigation plan requires any further reconsideration along with the comments of the Chief Wildlife Warden.

**Reply:**-The wildlife mitigation plan was prepared by the District Forest Officer, Bhadradri Kothagudem based on field conditions and requirements of the area. The physical targets and financial projections for each component were fixed on unit cost and were vetted by the CCF/Conservator of Forests, Bhadradri Circle. There are no Wildlife Sanctuaries / National Parks / Biosphere Reserve or Tiger Corridor in the study area. However, in the area falling within a radius of 10 Kms from the project site schedule – I species i.e., Monitor Lizard and Peafowl were identified apart from certain Schedule – II species. The mitigation plan was prepared for conservation of the species falling in the study area and was examined and approved by the Chief Wildlife Warden, Telangana. No further changes or additions are required for the mitigation plan prepared and approved.

**Point No.4:-**In the Biodiversity Report submitted by the State Govt., in the conclusion it states that there are 313 species of plants and 191 animals. However, it concludes by stating that there is no effect on wildlife mitigation due to mining. This seems contradictory, the State Govt. shall offer its comments in this regard.

**Reply:**- M/s.SCCL has informed that SCCL has started mining in this area in 1930s by underground method and from 1998 onward opencast mining was commenced. Since the mining had been in progress for several decades, the wild animals of the area have moved away to surrounding adjoining forest areas. As such there is very little presence of wild animals in the project area now being proposed. However, as per the report of District Forest officer and other field staff, movement of wild animals like Chital, Civets, Jackal and some few species of reptiles in the surrounding areas cannot be ruled out. Therefore a wildlife mitigation plan has been prepared to address the possible impact of proposed mining on wildlife of the area for Rs. 478.60 lakh. In addition to this, the DFO in his report suggested to have a chain link fence along the mining area and also creation of Bio-fence of 100 mts width with bamboo breaks, dense planting of shrubs and trees all along the perimeter at the cost of the user agency to minimize the impact on wildlife of the area.

**Point No.5:-**The State Government shall clarify why the instant proposal was applied for underground mining rights earlier (initially) and provide justification for proposed open cast mining

Reply:-It is submitted that the mining operations are being carried in SCCL since 1889. Since inception, underground mining by Board & Pillar method was predominant method of mining in SCCL as well as in the Country. The UG Mines were started in this area i.e., Kothagudem, way back in 1950 by Underground method as it was only option available during those days. The technology for deep seated Coal mining by opencast method was not in practice due to limitation of OC technology. Further, UG mining was considered as it is also having huge potential for employment generation. The opencast mining was commenced in SCCL only after 1975 and gained momentum thereafter with advancement in Open cast technology and increase in demand.

In the instant proposal, UG Mines viz., PVK No.5 Incline and VK No.7 Incline UG Mines of the Kothagudem area had started in 1950's with Board & Pillar with hand section drills. Later, Mechanized technologies such as Blasting Gallery, Longwall Mining and Continuous Miner Technologies etc., were introduced in these mines and extracted 67.24 million tones as on 31.03.2023.

At this juncture, it is not possible for any further underground mining as the reserves mine able by UG method were already exhausted in VK No.7 Incline and will be exhausted in PVK No.5 Incline by 2029-30. Hence, VK No.7 Incline is proposed for conversion into OC and PVK No.5 Incline will also be converted into OC after exhaustion of the mineable reserves with UG Mining i.e., by 2029-30.

As such, the present Opencast proposal is not an alternative to UG method and only intended for extraction of coal blocked after completion of extraction with UG mining for better conservation and viability and also to ensure committed coal supplies to linked power plants. The estimated balance reserves proposed to be extracted by Opencast Mining as on 01.04.2023 from these two UG Mines is 170.08 Mt. Due to availability of limited virgin coal reserves in Godavari valley coal field, SCCL has been converting closed UG Mines, after exhaustion of reserves mineable by UG method, into opencast. Even, adjoining closed Gautham Khani Opencast mine (GKOC) was an amalgamation of 3 UG mines (8 Incline, 9 Inclines, 10 & 11 Inclines). The GKOC was producing about 4 MPTA was closed in the year 2022-23 which was supplying coal to nearby Kothagudem Thermal Power Plant (KTPS-1800 MW). Therefore SCCL has proposed VKOC as a rely project to compensate this loss of

production.

In case this mine is not taken up, about 170 Million tones of coal will be lost forever as there is no feasibility to continue these UG mines by any method/technology and will have a impact on coal supplies to KTPS.

**Point No.6:-**The State Govt. shall provide details of utilized coal resources and available resources of coal in underground mines in the lease area and also will be made available through open cast mining as proposed

**Reply:**-The details of utilized coal resources and available resources of coal in UG mines in the lease area and coal reserve which will be made available through opencast mining as proposed are as follows:

**Point No.7:-**The IRO shall examine the compliance of the conditions stipulated in the earlier approval which are linked to the instant proposal and submit its report to the Ministry. The State Govt. shall provide the compliance report to IRO in this regard

**Reply:-**The annual Compliance reports of the approval accorded under F ( C ) Act, for projects were submitted to the Nodal Officer (FC), Telangana, with a copy to the Integrated Regional Officer, Hyderabad, the Chief Conservator of Forests, Bhadradri Circle and District Forest officer, Kothagudem, vide letter KGM/EST/F/25/224 to 228, Dt. 16.05.2023.

The diversion proposal were inspected by the District Forest Officer, Kothagudem in field on 15.05.2023. The Chief Conservator of Forests, Bhadradri Circle has

forwarded the compliance report on the Stage-II conditions for the 154.96 Ha, 124.00 Ha, 161.31 Ha and 1174.18 Ha. (copies enclosed)

**Point No.8:-**Further, the State Govt. shall provide updated regarding the handover of the land identified CA purpose to the State Forest Department w.r.t the proposal for 1st Renewal for diversion of 124 ha. (Surveyed 124.065 ha.) of forest land for coal mining in favour of M/s SCCL for GKOC Phase-II, Kothagudem in Ramavaram RF of Kothagudem Division, Bhadradri, Kothagudem District, Telangana and the same shall be mutated and transferred in the name of State Forest Department.

#### Reply:-

- A. It is submitted that the CA land of 124.00 Ha (part of 233.77 Ha.) was handed over to Forest Department in Sy.No.116 of Rasannagudem village of Mulakalapally Mandal of erstwhile Khammam district on 06.03.1990 and the same was mutated in favour of Forest Department vide Mandal Revenue Officer, Mulakalapally Rc.No.B/912/97, dt.07.07.1997. The CA area was free from encroachment at the time of handing over and encroachments might have happened in subsequent years.
- B. CA scheme was prepared for taking up CA in 124.00 Ha for an amount of Rs.49,60,000/- and the SCCL has deposited the amount on 23.11.1998. Due to high density of tree growth existing in the said area, CA Plantation was carried out in alternate degraded Forest land identified in Compt.No.7 of Kondapur Block, Aswapuram Range, Paloncha Division in (4) bits.
- C. Out of CA land handed over, only area of 42.96 Ha is available (free from encroachment) and having good forest growth with more than 0.6 density as such no use of any further planting. The remaining area of 81.04 Ha is under encroachment and it may not be possible to evict the encroachments. Moreover, Compensatory afforestation has already been raised at alternate place at Aswapuram with the money deposited by SCCL.
- D. However, in view of urgency in grounding of the proposed project of VKOCP, the SCCL has requested that against the area found to be under encroachment and area allocated to the I &CADD department (81.04 + 61.66 =142.70 Ha), land may be apportioned from the Non Forest land of 212. 04 Ha handed over as land bank in Chunchupally, Wadaguda and Ramachandrunipeta villages (i.e. Rajupeta CA Block)of Mangapet Mandal. This land was handed over vide charge certificate dt. 07.09.2007 and mutated vide Lr No. B/1452/2007 dt.07.09.2007 by Tahsildar. This land was initially intended to be given towards other projects of the SCCL, but it was not allocated to any project.

- E. This area (212. 04 Ha) was initially meant to be used for CA plantation for the project JVR OC -II for 776.20 hac of SCCL duly submitting the proposal to Moef for stage I approval. Meantime the SCCL was accorded CPSU status during 2013 by MOEF and accordingly while granting Stage I approval Vide File No 8-56/2014-FC dated 10-12-2014, MOEF stipulated condition no 2 (II) stating that the Forest department shall raise CA plantations over the degraded forest land (twice in extent) to the area of proposed forest for diversion at the cost of UA. This CA DFL was later on raised by the Forest department. The above mentioned area (212.04 hac) was however remained as land bank with Forest department. At present this area is having good tree growth and well protected.
- F. Out of this 212.04 hac area of NFL , KML files of 81.04 Ha and 61.66 Ha are enclosed. It is requested to allocate 142.70 Ha. from this land bank towards compensating the land for 124.00 Ha proposal.

As the above Non-Forest (212.04 hac) handed over by the SCCL is alreday in possession of the Forest department, it is requested to recommend the MOEF CC to consider an area of 142.70 hac out of above land as alternate Non -Forest land in place of 81.04 hac of encroached and 61.66 Hac overlapped land ( ICAD) for consideration of this proposal and forward the same to IRO Hyderabad with above remarks for consideration and according stage-I approval.



Adverting to the reference 2<sup>nd</sup> cited above, the District Forest Officer, Bhadradri Kothagudem has submitted that, the General Manager, Singareni Collieries Company Limited, Kothagudem Area has submitted the condition wise compliance report on Stage-II approval accorded vide reference 1<sup>st</sup> cited for diversion of 124.00 Ha of Forest land for OCP (GKOC) Phase-II, Kothagudem in Ramavaram RF & Range of Kothagudem Division of Bhadradri Kothagudem District (Erstwhile Khammam District) in favour of M/s. Singareni Collieries Company Ltd., Kothagudem Area, the same is submitted herewith as follows after the field inspection of the undersigned.

Condition No.(1): Legal status of the forest land shall remain unchanged.

**Compliance:** The legal status of land remains as Reserve Forest.

<u>Condition No.(2):</u> Compensatory Afforestation shall be raised over equivalent non-forest land at the project cost.

Compliance: The SCCL has handed over non-forest land of 124 Ha to the Forest Department on 06-03-1990 towards CA. This land is part of 495.08 Ha situated in Sy.No.116 of Rasannagudem (V), Mulakalapalli (M), Paloncha Forest Division and handed over to the Forest Department. The SCCL has paid Rs.49,60,000 to the Divisional Forest Officer, Paloncha on 23-11-1998 towards CA charges. The SCCL paid cost of CA (124.00 Ha.) amounting to Rs.49,60,000/- vide Cheque No.32932, dtd.23.11.1998. Further, the State Government vide letter No.15050/For.I/97-7, dtd.08-01-1999, confirmed the above CA land, while forwarding the proposal to MoEF, Gol.

Due to high density of tree growth in the area (NFL) already handed over to Forest Dept., alternate degraded Forest land of 124.00 Ha., suitable for raising plantation was identified and taken up planting as detailed below in Aswarapuram Range of erstwhile Paloncha Division now in Manuguru Division of Bhadradri Kothagudem District. Due to bifurcation of divisions and circles records are not available for identifying exact locations.

# <u>Condition No.(3)</u>: Demarcation of mining lease area will be done on the ground with RCC pillars with serial number and bearing and distance from pillar to pillar at the project cost

**Compliance:** Since the mining lease area is for the open cast quarry purpose, the entire area of 124.00Ha has been de-coaled this has disturbed all pillars in the Opencast mining, as the project is surrounded by other opencast mines which are continues, hence In the area filled with over burden 14 nos. pillars had been constructed (KML attached). Out of 28 pillars, only 14 pillars are seen.

Condition No.(4): The non-forest land transferred to Forest Department for Compensatory Afforestation shall be declared protected forest/reserved forest under Indian Forest Act, 1927.

Compliance: The SCCL has already handed over the Non-forest land measuring 124.00 Ha. in Rasannagudem (V) to the Divisional Forest Officer, Paloncha on 06.03.1990. This area forms part of total area measuring 495.08 Ha. of Non-Forest land in Sy.No.116 of Rasannagudem (V) of Mulkalapally Mandal, which was handed over to Forest Department towards CA land for various projects of SCCL. Out of the total area of 124.00 ha handed over for this project an area of 81.00 Ha is under encroachment and an area of 23.77 ha was falling short after the survey, accordingly an equivalent area of 23.77 Ha has been identified by SCCL authorities at JKOC-2 OB dump in Khammam District of Singareni Mandal (Reference attached). Further it was observed that an area of 81.00 ha is under encroachment before 2005 by local tribes (Report of DFO, Bhadradri Kothagudem District attached). Accordingly the SCCL has given undertaking for providing alternative non forest land at Mangapet of Mulugu District (Undertaking attached). Notification was not taken up due to above mentioned issue.

<u>Condition No.(5)</u>: The User Agency will transfer funds for fencing, protection, regeneration of safety zone area and also the cost of afforestation over one and half time of the safety zone area degraded elsewhere in favour of Forest Department

**Compliance:** An amount of Rs.3.66 lakhs was paid to Divisional Forest Officer, Kothagudem on 23.11.1998 towards plantations in safety zone area and afforestation in  $1\frac{1}{2}$  times of safety zone area. Safety Zone area for 124 Ha. cannot be maintained as the area is in the middle of the Quarry. However Safety Zone area is maintained around the project. (KML & Plan attached).

Condition No.(6): Reclamation of mined area will be done as per the approved plan at the cost of User Agency. Soil conservation and afforestation work around OB dump area should be carried out to control soil erosion from that area.

Compliance: The entire area was de coled by open cast quarry. Now this void area is proposed for dumping of over burden from the proposed VK CM (VenkteshKhani CM) and accordingly revised Mining Plan (copy enclosed) got approved from the MOC vide reference No.38077/12/2017-PCA, dt.12.09.2019. The reclamation of this area will be taken up as per revised approved mining plan. As on date about 65Ha Plantation is done on over burden dump and 59 Ha Is void. Further, it is to note that the plantation done on 65 Ha will be damaged for VKCM (fresh mine) dumping operation and total plantation (124Ha.) will be done in 20th year (i.e.2043) as per the revised approved mining plan of VKCM.

Condition No.(7): OB dump and mined out area of Phase-I will be reclaimed by the user agency within next one year and plantation will be taken up and report in this regard will be submitted to this office and Regional Office at Bangalore.

**Compliance:** SCCL vide letter No. GMK/ASO(SUR)/ 61A/2K/96 dated 11.04.2000 requested GOI for deletion of condition (7), as it is not in consonance with condition No.6 and the GOI vide letter No. 8-17/98-FC, dated 01.01.2002 amended and communicated the same to read as " in a phased manner as per approved Reclamation Plan" instead of within next (1) year.

The reclamation is being done as per approved EMP and approved plan od VKCM. A Half yearly Environmental Monitoring report is regularly submitted to The Director, Regional Office, MoEF&CC Hyderabad. The recent report (April-2022 to September-2022) was submitted vide Lr.No.KGM/ENV/401/160, dtd 26.11.2022. Coal excavation was completed in the year March,2019. Dumping of OB in under progress in 83.98 Ha and balance 40.02 Ha. Will be completed by the end of year 20th year (i.e.2043) as per approved VKCM mine closure plan. Further it is noticed that the mining closure plan of VKCM will be implemented for this project instead of GKOC (124.00 Ha opencast is part of GKOC), for which mine closure plan is approved by MOC in the year 2020 and is valid till 2040 (Mine closure plan approval vide GOI Ministry of Coal File No. PCA-38011/12/2017-PCA, dt: 27.01.2020 attached)

## Condition No.(8): The lease period will be for 20 years.

<u>Compliance</u>: The lease period is for 20 years. The renewal proposal was submitted well in advance on 28-03-2018 by SCCL and State Government vide letter No.1069/For.I/2019, dtd.29-10-2019 has forwarded the proposal to MoEF&CC, GoI, recommending for renewal. Mining Lease under MMDr Act is valid up to 26.04.2029.

<u>Condition No.(9)</u>: The user agency will provide free fuel wood to labour and staff working at the project site so as to avoid any pressure on adjoining forest land

**Compliance:** The SCCL is providing LPG to all its employees at free of cost @ 12 cylinders per annum.

<u>Condition No.(10)</u>: Proper drainage pattern should be provided and maintained in the project area.

**Compliance:** The total diverted area was meant for Mining (Quarry) operations. The total drainage over the surface was broken up and the water flowing on the surface was impounded in void. There was no major/minor stream over the surface.

<u>Condition No.(11):</u> The SCCL should not burn on coal at the project site as well as project for manufacturing soft coke or household coke

**Compliance:** Coal burning is not taking place in SCCL for making soft coal.

<u>Condition No.(12):</u> This approval is subject to Environment Clearance under Environment (Protection) Act.

**Compliance:** MoEF vide letter No.23-254/2018-IA.III (V), dt.20.05.2021 and accorded Environmental Clearance for GKOC (Copy attached).

<u>Condition No.(13):</u> Any other condition that the State Government may impose from time to time for the protection and improvement of flora and fauna in the forest area

<u>Compliance:</u> No other condition was stipulated. The SCCL will abide with any condition if imposed in future.

In this regard, the District Forest Officer, Bhadradri Kothagudem has requested to forward the compliance report on Stage – II approval to the Prl.Chief Conservator of Forests (HoFF), Telangana, Hyderabad for further action.

Therefore, based on the report of the District Forest Officer, Bhadradri Kothagudem, compliance report on Stage – II approval for the above project is submitted to the Prl. Chief Conservator of Forests (HoFF), TS, Hyderabad in (04) sets for taking further action in the matter.

Adverting to the reference 3<sup>rd</sup> cited above, the District Forest Officer, Bhadradri Kothagudem has submitted that, the General Manager, Singareni Collieries Company Limited, Kothagudem Area has submitted the condition wise compliance report on Stage-II approval accorded vide reference 1<sup>st</sup> cited for diversion of **154.96 Ha** of Forest land for Gouthami Khani OCP Phase-III in Ramavaram RF & Range of Kothagudem Division of Bhadradri Kothagudem District in favour of M/s. Singareni Collieries Company Ltd., Kothagudem Area, the same is submitted herewith as follows.

Condition No.(1): Legal status of the forest land shall remain unchanged.

**Compliance:** Legal status of land remains as Reserve Forest.

<u>Condition No.(2)(i)</u>: Compensatory Afforestation shall be raised and maintained by the State Forest Department at the project cost.

<u>Compliance:</u> CA land was identified in Sy. No. C B of Mulapet (V), Ranasthalam (Mandal), by the SCCL and handed over to Forest Department, Srikakulam Forest Division. An amount of Rs.82,08,000 was deposited vide DD Nos. 49419 to 49426, dtd.18-4-2008 towards CA charges. Report may be obtained from state of Andhra Pradesh.

Condition No.(2)(ii): Fencing, protection and regeneration of the safety zone area (7.5 meters strip all along the outer boundary of the mining lease area) shall and a half times the area under safety zone, shall be done at the project cost. Besides this, afforestation on 100 meter radius of mining lease granted in degraded forest land if density is less than 0.4/enrichment plantation shall be taken up by the user agency in consultation with the Forest Department.

**Compliance:** The SCCL has deposited Rs. 2.890Lakhs towards 1½ times safety zone, Rs.7.690Lakhs towards fencing of safety zone area and Rs.0.220Lakhs towards regeneration of safety zone area with DFO, Kothagudem on 14-09-2006 vide Cheque No.239739 of SBH, Rudrampur

Regarding planting in 100M radius from the Mining Lease periphery, the Forest Range Officer, Ramavaram has identified availability of degraded forest land of 6.00 Ha. within 100 meters radius where density is less than 0.4. This area was planted during 2016 planting season. (KML file attached)

Planting all around in 100m could not be done as this diverted area is surrounded by Mine (Open Cast quarry) and Non-forest land on 3 sides.

Condition No.(2)(iii)): Where ever possible and technically feasible, the User Agency shall undertake afforestation measures in the blanks within the lease area, as well as along the roads outside the lease area diverted under this approval, in consultation with the State Forest department at the project cost.

**Compliance:** Since the forest land diverted was for OC mining, it was not possible to take up plantation in the area during mining operations. The area will be planted only after completion of mining and re-filling with OB as per EMP. The SCCL has taken up avenue plantation in its area is 2.00 Ha. (Avenue plantation in length of 910mtrs.) (KML attached).

Condition No.(3): The recommendations made in the Impact Assessment Study carried out by Indian Council of Forestry Research and Education(ICFRE) shall be implemented at the project cost.

**Compliance:** As per the recommendations made ICFRE, suitable compliances including sprinkling of water along the haul roads, removal of used oil barrels, de-silting of tanks, plantation etc., have been made apart from other social welfare activities. However it has been informed to SCCL to comply all the recommendations of ICFRE in next 5 years under the supervision of forest department and quarterly DPR to be sent to District Forest Officer.

Condition No.(4): The scheme for soil and moisture conservation for the entire watershed area shall be implemented at the project cost.

**Compliance:** The SCCL has taken up construction of toe wall (3.90 Km), garland drains (9.60 Km) along the OB dump and 3 siltation ponds, 8 cribs, 8 Rock fill dams in GKOC Project at the cost of Rs.1.30 Crores.

Condition No.(5): The non-forest land proposed for compensatory afforestation should be transferred and mutated in the name of Forest department and should be declared as Reserve Forests.

<u>Compliance:</u> 154.96 Ha. of non-forest land identified in Sy.No. CB of Mulapet (V), Ranasthalam (M) of Srikakulam Division was handed over and mutated in favour of Forest Department on 30-01-2001, Srikakulam Division. compliance report may be obtained from the state of Andhra pradesh.

<u>Condition No.(6):</u> All measures should be taken to prevent pollution of tanks, rivers and nalas, etc. The desilting of adjoining villages in radius of 5 Kms may also be taken up by the User agency from time to time

**Compliance:** De-silting of village tanks such as Erracheruvu in Penagadapa village was done. (Enclosed as Annexure-1). The SCCL has taken up construction of toe wall (0.839Km), garland drains (3.53Km) along the OB dump and 1 siltation ponds in GK OC Project at the cost of Rs.0.153 crores. In addition to the above 12969cu.mtrs of silt was removed in 1 penagadapa settling ponds at the cost of user agency with departmental equipment. The cost of Rs.0.43 crores.

Measures have been taken not to allow soil wash (runaway of soil), even all the garland drains are being de-silted regularly. Further, Agave suckers, Saccharum Munja &Vetivers were planted for soil binding and prevention of erosion. Broadcasting of Stylosantheshamata was also done which prevented the soil erosion as well as improved nutrient status. 8 Gabion structures, 8 Rock fill dams, cribs were also provided to prevent further erosion. Stabilization of slopes & dump tops is being done immediately after completion of dump to prevent soil erosion.

De-silting of village tanks such as Penagadapa Tank (0.1 Km) was done (Photos Soft copy attached).

<u>Condition No.(7):</u> The period of diversion under this approval shall be twenty (20) years subject to possession of valid lease by the User Agency under the MMDR Act, 1957.

**Compliance:** Yes, the lease period will be 20 years (Lease expiry as per Stage-II approval vide F.No.8-62/2005-FC, dt. 09-07-2008).

Condition No.(8)(i): The User Agency shall take up Planting work on the static dumps during the advance mining operations and the toe wall around the dump shall be taken up by the user agency.

<u>Compliance:</u> Planting work on the static dumps was taken up in a phased manner as per the EMP and so far about 55.15Ha. of OB dump area has been reforested. Further, this area will be used for OB dump of VKOC, final closure will be done as per revised VKOC mine closure plan.

<u>Condition No.(8)(ii):</u> All the dumps shall be fully reclaimed by afforestation immediately after closure of the mine in the shortest possible period under supervision of the State Forest Department.

<u>Compliance:</u> Reclamation was started in 1999, every year technically and biologically reclaimed up to the year of 2018. As on date at about 55.15Ha. Plantation was done. 99.81Ha. without plantation area. and Plantation (154.96Ha.) will be done 20th year (i.e.2043) as per approved mining plan of VKCM. The reclamation of mined area will be taken up as per revised approved mining plan.

<u>Condition No.(9):</u> Any tree felling shall be done only when it is absolutely necessary and unavoidable, and that too under strict supervision of the State Forest Department.

<u>Compliance</u>: Since the area diverted was for OC mining, it was handed over by the Forest Department after extraction of tree growth.

Condition No.(10): No damage to the flora and fauna of the area shall be caused.

Compliance: SCCL has complied.

Condition No.(11): For reclamation works, the top soil should be preserved and should be used for reclamation. The areas shall be reclaimed keeping in view the international practice of stabilizing the dumps by grading / benching so that angles of repose (normally less than 280 at any given place) are maintained.

<u>Compliance:</u> Top soil management is being followed as per approved EMP. So far, top soil spread over OB dump is 3.40Mcum Balance Top soil 1.60Mcum preserved in 880RL deck will be used for reclamation of VKCM OB dump yards As per approved plan of VKCM,

OB dump yards. Fresh OB will be dumped in GKOC void area.

<u>Condition No.(12):</u> The reclamation plan including siltation tanks shall be implemented and monitored continuously. The User Agency should furnish the extent of area to be technically and biologically reclaimed each year, to facilitate monitoring. The annual report about the progress of reclamation should be submitted to the Chief Conservator of Forests, Regional Office, Bangalore

**Compliance:** The SCCL has taken up plantation 55.15Ha in 154.96Ha. Reclamation was started in 1999, every year technically and biologically reclaimed up to the year of 2018.

The last compliance report was submitted to the MoEF&CC, vide Lr.No.KGM/ENV/401/83, Dt.26.05.2022 for the period ending March, 2022.

<u>Condition No.(13):</u> It shall be ensured that no labour-camps are set up inside the forest area

**Compliance:** No labour camp is there in Reserve Forest.

Condition No.(14): The mining lease area shall be demarcated on ground at the project cost, using four feet high RCC pillars, with each pillar inscribed with the serial number, forward and backward bearings and distance between two adjacent pillars

Adverting to the reference 2<sup>nd</sup> cited above, the District Forest Officer, Bhadradri Kothagudem has submitted that, the General Manager, Singareni Collieries Company Limited, Kothagudem Area vide reference 2<sup>nd</sup> cited has submitted the condition wise compliance report on Stage-II approval accorded vide reference 1<sup>st</sup> cited for diversion of **161.31 Ha** of Forest land for Gowtham Khani Opencast Project Phase –I in Kothagudem Division of Bhadradri Kothagudem District in favour of M/s. Singareni Collieries Company Ltd., Kothagudem Area, the same is submitted herewith as follows.

Condition No.(1): Legal Status of the forest land shall remain unchanged.

**Compliance:** Legal status of the land remains as Reserve Forest.

Condition No.(2): 100 Ha. of forest land proposed to be surrendered to the State Forest Department shall be done immediately with a compliance to the Central Government however, it should be maintained by the User Agency at their cost under the guidance of the Forest Department.

Compliance: The area of 100 Ha duly rehabilitated was surrendered to the Forest Department on 07.07.2010. This area is being maintained by the SCCL under the guidance of the Forest Department. 

Out of 35 pillars, only 27 pillars existed in the quarry as the area is totally extracted and the pillars are also re-constructed in the dumped area.

Condition No.(10): Mining/reclamation schedule shall be implemented by the user agency at their cost as per Environmental Management Plan/ phased programme.

Compliance: Out of 261.31 Ha an area of 100 Ha after rehabilitation was surrendered to the Forest Department on 07.07.2010. This area is being maintained by the SCCL under the guidance of the Forest Department. Coal excavation was completed in the year August, 2019. Dumping of OB in under progress. And as per approved VKCM mine closure plan 161.31Ha. Will be completed by the end of year 20th year (i.e.2043)

Condition No.(11): The User Agency shall also take up study on soil erosion/soil flow from the overburden areas with the help of GIS in consultation with the Forest department

Compliance: The SCCL has provided 1.101 Km. Toe wall and 6.581Km., garland drains around the OB dump and 2 settling ponds and 1.566 Km. garland drains on decks. Measures have been taken to prevent soil wash (runaway of soil). All the garland drains are being de-silted regularly. Further, Species of plants planted in GKOCP Dendrocalamusstrictus, Hardwickiabinata Inga dulcii, Albeziaodoratissima, Ficusbenghalensis, Ficuspelegiosa, Semaroubaglauca, Ceibapentandra, Ficusmollis Aegle

marmolose, Mytragynaparvifolia Dolichondrancrispa, Madhukalatifolia Terminaliabellarica, Eucalyptus clones etc. Agave suckers, Styloxanthushamata & Saccharammunja etc were planted for soil binding and prevention of erosion. Gabion structures and cribs were made to prevent further erosion from slopes. Stabilization of slopes & dump tops is being done immediately after completion of dump formation to prevent soil erosion. SCCL has carried out in-house soil erosion study. As per study the soil loss is about 1.5 Tonnes /Ha, but this soil is stopped by the toe walls, garland drains and siltation ponds and not allowed to go out of lease area. The drains are regularly de-silted. Further, user agency was informed to assist forest department in conducting study on study on soil erosion/soil flow from the overburden areas with the help of GIS. DPR has been prepared for implementation.

Condition No.(12): The User Agency shall take up the de-silting of the village tanks within 5 Km. radius from the mine lease boundary so as to mitigate the impact of siltation of such tanks whenever required.

Singareni Collieries Company Ltd., Kothagudem Area, the same is submitted herewith as follows.

Condition No.(1): Legal status of the forest land shall remain unchanged.

**Compliance:** The legal status of the land remains as Reserve Forest.

Condition No.(2): The State Government shall charge the Net Present Value (NPV) for the forest area proposed for renewal to be diverted under this proposal from the User Agency as per the orders of the Hon'ble Supreme Court of India dated 30.10.2002, 01.08.2003, 28.03.2008 and 09.05.2008 in I.A. No.566 in WP(C) No. 202/1995 and as per the guidelines issued by this Ministry vide letters No. 5-1/1998-FC (Pt.II), dated 18.09.2003, as well as letter No. 5-2/2006-FC, dated 03.10.2006 in this regard.

<u>Condition No.(13):</u> The User Agency shall take up the de-silting of the village tanks within five KM area from the mine lease boundary so as to mitigate the impact of siltation of such tanks whenever required.

<u>Compliance:</u> As it is an underground mining, question of soil erosion due to mining activity does not arise. However, SCCL has taken up de silting in Tungaram Tank of Tekulabanjara and Penagadapa Tank at the cost of Rs.1.02 Crores, the silted soil was taken over by the local farmers to their fields. (Enclosed as Annexure-1).

<u>Condition No.(14):</u> The forest land shall not be used for any purpose other than that specified in the proposal.

**Compliance:** The land is being used for the purpose only for which permission was obtained.

<u>Condition No.(15):</u> Any other condition that the CCF (Central), Regional Office, Bangalore/ State Government may impose from time to time for protection and improvement of flora and fauna in the forest area, shall also be applicable.

**Compliance:** SCCL has submitted undertaking.

In this regard, the District Forest Officer, Bhadradri Kothagudem has requested to forward the compliance report on Stage – II approval to the Prl.Chief Conservator of Forests (HoFF), Telangana, Hyderabad for further action.

Therefore, based on the report of the District Forest Officer, Bhadradri Kothagudem, compliance report on Stage – II approval for the above project is submitted to the Prl. Chief Conservator of Forests (HoFF), TS, Hyderabad in (04) sets for taking further action in the matter.
