# Note on Importance of area from wildlife points of view and conservation measures.

The Dosti Agro Tourism Center at village Karanjale, Tal-Junnar, Dist- Pune is in Malaki farm Land Gat No. 142, area 1.92 ha. The surrounded area of this agro Tourism Center is Forest compartment No. 64, S. No./G. No. 120. The said area is high precipice peak as well as having steep slope about 15 to 20 degree which falls under protection area (Type A) as per the working plan. So also the said area is under the catchment area of Pimpalgaon-Joga Dam.

The Wildlife Conservation Plan for the said area from the point of view of conservation of scheduled — I species is as follows:-

- A) Soil conservation works like continuous contour bunds (CCB) check dams, gabian bunds which prevents soil erosion due to heavy rainfall. CCB will also to prevent fire hazards and to keep the soil layer intact which subsequently is useful giving suitable habitat for wildlife
- B) Planting of soil retaining trees eg- Sisal, Sabar, and grasses Grass planting like Dongri Marvel, Pawanya, Sheda which will in turn help to prevent soil erosion & excess water runoff
- C) Planting of Hirda, Ain, Behda, Jambhul, Mango, Karvand etc. wherever soil layer is sufficient. These fruits are beneficial for wildlife conservation.
- D) Planting bamboo on both sides of streams and drains and where the soil depth is medium to deep. Planting bamboo will support the development of ground cover and terrestrial vegetation and wildlife habitat which is a very



important hiding place for the safety of scheduled I species like Sambar, Leopard, Indian cobra, Indian porcupine, Russels Viper.

E) Creation of two saucer shaped water holes for providing water to wildlife during summer season.

2) The Dosti Agro Tourism Centre is at the top of Mountain in Gat No.142. There is no permanent water source available for drinking water as well as for Agro Tourism purpose, no facility of electricity and proper route for throughfare available here. In thi regard the User Agency has submitted proposal Forest (Conservation) Act, 1980 for Water, Eletricity, approach road etc.,

3.0 Following documents as prescribed in Government Circular, Revenue and Forest Department No.FLD-1081/2041/(A)/F-3, dated 20/03/1982 and according to Government of India's instructions issued from time to time are enclosed in two copy.

- 3.1 Prescribed form dated 10/01/2003.
- 3.2 Certificate regarding minimum demand of forest land for the project,
- 3.3 Area Statement,
- 3.4 Index map in suitable scale
  - 4) The total non forest involved in project is .099 ha.
  - 5) Cross section map enclosed on page No119 to 121.

- 6) The site inspection report of the Deputy Conservator of Forests, Junnar Forest Division, Junnar is enclosed on page no.48 to 50.
- 7) No alternate alignment is possible and the forest land required is minimum.
- 8) The area belongs to Eco-value class-III having density is below 0.4 to 0.7 (Dense Forest).
- 9) There are no tree felling involved in this project.
- 10) The area involved in the project does not form part of any existing National Park, Wildlife Sanctuary, Nature Reserve etc.
- 11) Proposed project is not likely to affect any monumental site of cultural, historical, religious, archeological or recreational importance.
- 12) There is violation of Forest (Conservation) Act 1980. The detail violation report is enclosed on page No.
- 13) Proposed project is 5.5 kms from the boundary of the Protected Area i.e. Kalasubai Wildlife Sanctuary. The notification of Kalasubai Wildlife Sanctuary is enclosed on page No. 64 A to 64 H.
- 14) The non-forest area covered under the project is not under the provision of Maharashtra Private Forest (Acquisition) Act 1975 by virtue of application of Section 35 of Indian Forest Act 1927 and are not recognized as deemed reserved forest as well as not included in the area identified as "forest" as per dictionary meaning of forest as intimated to the expert committee appointed under interim judgment of the Hon'ble Supreme Court dated
- 15) Proposed Compensatory Afforestation over 1.00 ha. degraded forest land in Compt No.1(A), Gut No.45 of Village Khireshwar, Taluka Junnar, Dist. Pune and it is contiguous, suitable for afforestaion and management purpose and it is free from encroachment and an encumbrances.
- 16) Three alternatives have been examined in detail and no any other alternative available to the proposed work.
- 17) The User Agency has submitted an undertaking to defray the cost of Net Present Value
- 18) The User Agency has submitted an undertaking to defray the cost of Compensatory Afforestation.
- 19) The User Agency has submitted an undertaking regarding the compliance under the Scheduled Tribes and Other Traditional forest Dwellers (Recognition of Forest Rights) Act, 2006 has been applied and is under process and shall be submitted before formal approval as per Government of India vide letter No.11-43/2013-FC, dt.3/12/2018.
- 20) The Deputy Conservator of Forests, Junnar Forest Division, Junnar and Chief Conservator of Forest (T), Pune have recommended the proposal for diversion of 0.121 ha. of Reserved forest land.
- In view of this, the proposal is recommended for approval under the section -2 (ii) of the Forest (Conservation) Act, 1980 subject to the following conditions: -
  - 2.1 The legal status of the forest land required will remain unchanged.
  - 2.2 Forest land will be handed over only after required non-forest land for the project is handed over to the user agency.
  - 2.3 Compensatory Afforestaton:-
  - a) Compensatory afforstation shall be taken up by the Forest Department over 1.00 ha. degraded forest land in Compt. No.1(A), Gut No.45 of Village Khireshwar, Taluka Junnar, Dist. Pune at the cost of the user agency. As far as possible, a mixture of local indigenous species shall be planted and monoculture of any species may be avoided.
  - 2.4 The cost of compensatory afforestation at the prevailing wage rates as per compensatory afforestation scheme and the cost of survey, demarcation and erection of permanent pillars

if required on the CA land shall be deposited in advance with the Forest Department by the project authority. The CA will be maintained for 10 years. The scheme may include appropriate provision for anticipated cost increase for works scheduled for subsequent years.

#### 2.5 NPV:-

- a) The State Government shall charge the Net Present Value (NPV) for the 0.121 ha. forest area to be diverted under this proposal from the User Agency as per the orders of the Hon'ble Supreme Court of India dated 30/10/2002, 01/08/2003, 28/03/2008, 24/04/2008 and 09/05/2008 in IA No.566 in WP (C) No.202/1995 and as per the guidelines issued by the Ministry vide letters No.5-1/1998-FC (Pt.II), dated 18/09/2003 as well as letter No.5-2/2006-FC, dated 03/10/2006 and 5-3/2007-FC, dated 05/02/2009 & File No.5-3/2011-FC(Vol-I), Dated 06/01/2022 in this regard.
- b) Additional amount of the NPV of the diverted forest land, if any, becoming due after finalization of the same by the Hon'ble Supreme Court of India on receipt of the report from the Expert Committee, shall be charged by the State Government from the User Agency. The User Agency shall furnish an undertaking to this effect.
- 2.6 User Agency shall restrict the felling of trees to minimum number in the diverted forest land and the trees shall be felled under the strict supervision of the State Forest Department and the cost of felling of trees shall be deposited by the User Agency with the State Forest Department.
- 2.7 All the funds received from the user agency under the project shall be transferred/deposited to CAMPA fund only through e-portal (<a href="http://parivesh.nic.in/">http://parivesh.nic.in/</a>)
- 2.8 The complete compliance of the FRA, 2006 shall be ensured by way of prescribed certificate from the concerned District Collector.
- 2.9 User Agency shall raise strip plantation on both sides and central verge of the road as per the IRC norms.
- 2.10 Speed regulating signage will be erected along the road at regular intervals in the Protected Areas/Forest Areas.
- 2.11 It Shall mandatory to provide underpass for safe crossing of wild animals
  - (a) The underpass shall have a minimum size of width 4.00 mt and Height 3.00 mt.
  - (b) Wherever natural cross drainage works are in existence, then no need to construct new underpass subject to existing structure nearly complying above mentioned dimensions, as suggested in (a) above.
  - (c) Wherever natural cross drainage works are in existence but as per engineering requirement, it is required to reconstruct then that structure shall comply with the minimum dimensions as suggested in (a) above.
  - (d) Interval between such underpasses shall not be more than 2.00 km
- 2.12 The user agency shall provide suitable under/over pass in Protected Area/ Forest Area as per recommendation of CWLW/NBWL/FAC/REC.
- 2.13 User Agency shall obtain Environmental Clearance as per the provisions of the Environmental (Protection) Act,1986, if applicable.
- 2.14 The layout plan of the proposal shall not be changed without prior approval of Central Government.
- 2.15 No labour camp shall be established on the forest land.

- 2.16 Sufficient firewood, preferably the alternate fuel, shall be provided by the User Agency to the labourer after purchasing the same from the State Forest Department or the Forest Development Corporation or any other legal source of alternate fuel.
- 2.17 The boundary of the diverted forest land shall be suitably demarcated on ground at the project cost, as per the directions of the concerned Divisional Forest Officer.
- 2.18 No additional or new path will be constructed inside the forest area for transportation of construction materials for execution of the project work.
- 2.19 The period of diversion under this approval shall be co-terminus with the period of lease to be granted in favour of the user agency or the project life, whichever is less.

Specific Recommendation of Principal Chief Conservator of Forests, Maharashtra State (Head of Forest Force) Maharashtra State, Nagpur with regards to acceptance or otherwise of the proposal supported by reasons.

- 1) The proposal is for diversion of 0.121 ha. Reserved Forest land for construction of laying water pipeline, erection of electric pole to supply electricity, aerial iron cable for cable car and regularize existing approach stairs pathway for the Dosti Agro Tourism Centre at Village Karanjale Tal. Junnar, Dist. Pune in the State of Maharashtra (FP/MH/Others/42723/2019) has been initiated by the Shri. Sanjay Shridhar Awati, Project Authority & land holder, Dosti Agro Tourism Centre, at Village Karanjale, Tal. Junnar, Dist. Pune for seeking approval under Forest (Conservation) Act, 1980.
- 2) The Dosti Agro Tourism Centre is at the top of Mountain in Gat No.142. There is no permanent water source available for drinking water as well as for Agro Tourism purpose, no facility of electricity and proper route for throughfare available here. In thi regard the User Agency has submitted proposal Forest (Conservation) Act, 1980 for Water, Eletricity, approach road etc.,
- 3) The details of the forest land proposed for diversion are as under:-

- 5) Cross section map enclosed on page No119 to 121.
- 6) The site inspection report of the Deputy Conservator of Forests, Junnar Forest Division, Junnar is enclosed on page no.48 to 50.
- 7) No alternate alignment is possible and the forest land required is minimum.
- 8) The area belongs to Eco-value class-III having density is below 0.4 to 0.7 (Dense Forest).
- 9) There are no tree felling involved in this project.
- 10) The area involved in the project does not form part of any existing National Park, Wildlife Sanctuary, Nature Reserve etc.

- 11) Proposed project is not likely to affect any monumental site of cultural, historical, religious, archeological or recreational importance.
- 12) There is violation of Forest (Conservation) Act 1980. The detail violation report is enclosed on page No.
- 13) Proposed project is 5.5 kms from the boundary of the Protected Area i.e. Kalasubai Wildlife Sanctuary. The notification of Kalasubai Wildlife Sanctuary is enclosed on page No. 64 A to 64 H.
- 14) The non-forest area covered under the project is not under the provision of Maharashtra Private Forest (Acquisition) Act 1975 by virtue of application of Section 35 of Indian Forest Act 1927 and are not recognized as deemed reserved forest as well as not included in the area identified as "forest" as per dictionary meaning of forest as intimated to the expert committee appointed under interim judgment of the Hon'ble Supreme Court dated 12/12/1996.
- 15) Proposed Compensatory Afforestation over 1.00 ha. degraded forest land in Compt No.1(A), Gut No.45 of Village Khireshwar, Taluka Junnar, Dist. Pune and it is contiguous, suitable for afforestation and management purpose and it is free from encroachment and an encumbrances.
- 16) Three alternatives have been examined in detail and no any other alternative available to the proposed work.

Pune at the cost of the user agency. As far as possible, a mixture of local indigenous species shall be planted and monoculture of any species may be avoided.
  - 2.4 The cost of compensatory afforestation at the prevailing wage rates as per compensatory afforestation scheme and the cost of survey, demarcation and erection of permanent

pillars if required on the CA land shall be deposited in advance with the Forest Department by the project authority. The CA will be maintained for 10 years. The scheme may include appropriate provision for anticipated cost increase for works scheduled for subsequent years.

- a) The State Government shall charge the Net Present Value (NPV) for the 0.121 ha. forest area to be diverted under this proposal from the User Agency as per the orders of the Hon'ble Supreme Court of India dated 30/10/2002, 01/08/2003, 28/03/2008, 24/04/2008 and 09/05/2008 in IA No.566 in WP (C) No.202/1995 and as per the guidelines issued by the Ministry vide letters No.5-1/1998-FC (Pt.II), dated 18/09/2003 as well as letter No.5-2/2006-FC, dated 03/10/2006 and 5-3/2007-FC, dated 05/02/2009 & File No.5-3/2011-FC(Vol-I), Dated 06/01/2022 in this regard.
