Kindly refer to your office letter No.8B/HP/06/64/2020/FC/794 dated 31.07.2020 on the subject cited above.

- The pointwise reply of the observations as raised vide your above referred letter is submitted as below:-
  - 1. The User Agency has intimated that the said road is not in the list of 2183 roads intimated to the Hon'ble High Court Shimla H.P. This road has not been constructed by the Public Works Department so far. It is a bridle path of forest department and construction on this land/ proposed road has been done by the Forest Department. इस सम्बन्ध मे वन परिक्षेत्र अधिकारी नाचन द्वारा सूचित किया है कि गणी से भूरनी नाला तक रास्ते की मुरमत का कार्य विभाग द्वारा लगभग 17-18 वर्षों से करवाया गया है। इस की मुरम्मत के लिए कई वर्षों से धन राशि स्वीकृत की जाती थी व इस रस्ते की मुरमत का काम करवाया जाता था। पंचायत के द्वारा भी इस की मुरम्मत का कार्य किया जाता था।
  - 2. The calculation of Penal NPV has already been attached at Page 92 (B) in proposed folder.
  - 3. स्चना उपरोक्त मद संख्या 1 मे दे दी गयी है।
  - 4. The objection has been attended online and hard copy attached.
  - 5. User Agency has intimated that the villages to be benefited by the proposed road have been marked on the KML file and KML file also been uploaded through online in the web portal.
  - 6. User Agency has intimated that in the KML file the proposed alignment is linking two existing roads which are very important; therefore the proposal cannot be revised upto point No. 14 in the geo-referenced map. The Chail Chowk to Kot Devidarh road and Ner Chowk to Janjehli road both are already existing roads, which will be connected to the proposed Gani to BhoniNalla road. Hence, this road will provide shortest route to the people of villages; Jachh, Tunna, Bag, Dhangayara, Jahal, Devidarh who otherwise have to travel additional 30 Kms to move for Kandha, Bagsaid, Thunag and Janjehli etc. during the emergent conditions as well as for agrarian economy. Therefore, after the construction of this road it will provide the shortest route to aforesaid villages/people on the proposed road which will help saving their time and will also boost the local rural economy.

- 7. DFO Nachan has reported that no trees are involved over the forest land proposed for dumping sites.
- 8. User Agency has intimated that the calculation carried out in Annexure B-I have been corrected in hard copy regarding muck dumping plan and is sent herewith for necessary attachment with the proposal folder.
- 9. The check list Sr. No. 16 alongwith Digital Map for 4 ha. is enclosed and uploaded online.
- 10. DFO submitted the necessary certificate regarding no plantation has been done in the past over the proposed land, which is enclosed herewith.

It is therefore, the case after attending the observations is submitted for your information and further necessary action please.
