

1.	On Persual of KML file of the proposed area, it has been noticed that village are already connected with the existing road. In fact some alignment of proposed road going over the existing road. State Government may may submit eh justification of the proposed road and requirement of the road.	Due to the excess of sanctioning road the alignment was going over the existing road, in this regarding the alignment was restrict in km 4.200 instead of KM 5.00 therefore the affected civil soyam land is same for new maps & related documents of proposed road are uploaded in Form A, Part I and the hard copy also attached with this letter.
2.	State Government may submit the path distance of the villages from the nearest existing road.	In new restricted alignment of 4.20 km, dhari & Dhari Joshi Villages will be benefited. The path distance of Dhari josihi is 2.00 KM and Dhari villages is 4.200 from the nearest existing road.
3.	State Government is requested to mark the alternate alignment in the KML file of the proposed area and upload the same at para C in part I online.	Geo map with co-ordinates of alternate alignment shows as blue color has been uploaded in Para-C Form A part-I.
4.	State Govt. is requested to submit the details of the existing road, any approved under FCA obtained earlier and form where this road is starting.	User agency mentioned that the approved sanction letter with no- GI:-2756/7-1-2003-600(2698)/2009, dated 15-07-2013 of existing road under approval of FCA is attached with the letter.
5.	Details of alternative alignment uploaded at para D (ii)(a) is found incorrect. State Government may submit the details of alternative alignment at para D (ii)(a) in part I.	Geo map with co-ordinates of alternate alignment shows as blue color is uploaded at Para D (ii) (a) in part-I.
6.	Date is not found mentioned in the village level committee meeting proceeding of the pawan village, which may be submitted.	The Village level committee with date is uploaded in Part I, Form A.
7.	Name of the CA area not mentioned in the documents uploaded at para L (iv)f, g&h. State Government may upload the documents at para L after mentioning the same of the proposed CA area.	CA area is named as Papdev also uploaded in form A, Part I.
8.	State Government is requested to upload the clear copy of the CA Scheme. CA Site Suitability, Land Schedule, bar Chart and aerial Distance Certificate in online Part II.	The clear copy of the CA Scheme. Site CA suitability, land Schedule, bar Chart and aerial distance certificate have been uploaded in Form A, Part II.

9.	State Government is requested to upload the CA Scheme mentioning the name of the area proposed for CA.	CA scheme with name is uploaded in Form A, Part I.
10.	Details of girth wise trees mentioned at para 4 in Part II are not matching with details mentioned in the tree enumeration list uploaded in additional documents. For e.g. 80 saplings mentioned in 0-10 in tree enumeration list uploaded in additional document but detail of only 12 filled in 0-30 cm, State Government may remove this discrepancy and submit the correct information/documents.	Revised tree detail has been uploaded in Online form A Part-II as additional information.
11.	State Govt. is requested to submit the reclamation Muck Disposal Plan.	The reclamation muck disposal plan is uploaded in Form A, Part I.
