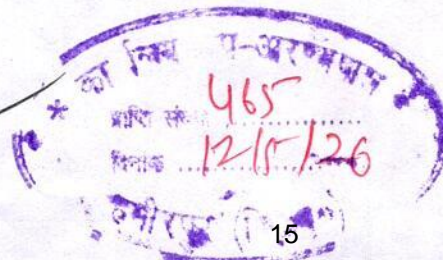
Please refer to EDS raised by IRO Chandigarh under reference on the subject cited matter. In this regard, it is submitted that as per the observations related to the 2183 case of violations has been raised by the O/o IRO Shimla. It is submitted that there is only one road pertaining to this division that has been reported under violation and the same is uploaded on the Parivesh Portal. And as per the observation related to uploading of all the remaining proposal on the portal is concerned, it is submitted that in total there are 51 roads falling under 6th Circle HPPWD Hamirpur which have been reported under violation. Out of it two proposals have been accorded Stage-II approval and 39 proposals have been uploaded on Parivesh Portal .only 4 proposals are yet to be uploaded.

Hence it is humbly requested that the above mentioned proposal may be forwarded to Higher authorities for acceptance as the proposed road is very important and the local people are facing too much difficulties, especially in Monsoon season.
