The point-wise reply/information to the shortcomings pointed out as furnished by DFO Bilaspur is as under:-

- 1. The water storage tank is proposed in Malroan Village over Khasra No. 1/1 measuring 0.01 ha. area. Moreover, as per marking lists placed in proposal folders at page 153 to 159, no tree is enumerated over above said land. However, a certificate in this regard as received from field staff is enclosed.
- 2. The user agency has mentioned all 13 components online in Part-I, Para B 2.4.
- 3. The user agency has submitted revised layout plan showing the water distribution system with measurements duly signed by the DFO which is uploaded online by user agency and hard copy is
- 4. As per point No. 3 above.
- 5. The user agency has uploaded KML file of alternative sites in online Part-I.

6. User agency has reported that all the alternatives have been examined but as per Notification dated 15.01.1952, all the Government land is notified as forest land. No other suitable private land is available in this area except small land holding and all the available land is forest land. Similarly, there is no non forest land available for the purpose. The Deputy Commissioner, Bilaspur has also issued certificate to this effect which is annexed at page 24 in proposal folders. However, it will be ensured that minimum felling of trees will take place.

- 7. The user agency has submitted Administrative approval and expenditure sanction of the Govt, which is enclosed herewith.
- 8. The detailed measurement related to the muck generation is submitted by user agency online as well as hardcopy which is enclosed herewith.
- 9. The detailed reclamation plan of muck dumping site is enclosed herewith which is also uploaded online in Part-II against additional information.
- 10. There are two trees in dumping site. The enumeration list of these trees is already placed in proposal folders at page-158.
- 11. As per user agency the land coming under water distribution system is not included in the diversion area.
