5	The copy of Sol toposheet map w.r.t proposed forest diversion land is not legible	Legible copy of Sol toposheet has been uploaded by use agency under column C(iii) in Part-I.
6	As per layout plan, the proposed forest diversion area is near to Sewa River. However, it has been mentioned that Project doesn't requires Clearance under the Environment (Protection) Act 1986. Looking at the gradient of land along the river, detailed muck disposal plan needs to be submitted including biological measures of slope stabilization	Detailed reply uploaded at Sr.No. 7 (additional documents).
7	CA scheme and CA area needs to be revised for 23x10=230 number of saplings plantation over an area of 0.23 ha of CA land. Accordingly, the DGPS map, SOI toposheet and Site suitability map shall be revised	The revised CA plan, DGPS map, SOI toposheet and site suitability map has been uploaded by DFO SF Kathua at Sr.No. 4 (Additional documents). As intimated by DFO SF Kathua the earlier CA plan uploaded under column 13(ii), 13(iii), 13(iv), 13(v) are not deletable on the portal, as such, revised documents have been uploaded at additional documents.
