The point wise reply of the observation a pointed out vide letter under reference has been attached as under:-

1.	The user agency has uploaded two proposal for the same with same area .One proposal No. FP/HP/TRANS/29322/2017 .Hence two proposal are pending out of which, the proposal No. FP/HP/TRANS/21269/2016, is pending at the level of user agency. The user agency is required to withdraw this proposal by forwarding the proposal at the Nodal Office level.	The old proposal No. FP/HP/TRANS/21269/2016 has been withdrawn and have re-submitted the new proposal No. FP/HP/TRANS/29322/2017.
2.	There is difference in employment likely to be generated, mentioned against column No.E in online part-I and given in hard copy of the proposal. Against column No.E(ii) '5' and against E(iii) , '300', has been mentioned whereas in hard-copy of part-I against column No.(vi), '204' person will be benefitted' has been mentioned. The employment details given in online part-I and mentioned in hard copy should match. Necessary correction are required to be made in the employment details.	The detail of employment likely to be generated and number of person to be benefitted from the project has been corrected in the online Part-I of the proposal and the same has been done in the hard copy also.

3.	Against C (iii) & C (iv), although the maps duly signed by the user agency have been uploaded. But as per GOI instruction these maps signed by UA and countersigned by DFO concerned are required to be uploaded.	The Digital map and Topo Sheet online duly signed by the user agency and countersigned by the concerned DFO has been uploaded.

9.	As per enumeration lists, 651 trees and saplings of different species are standing over the forest land proposed for diversion. The scientific name of all the trees has not been mentioned and other have been mentioned. 10.	In online part-II against column No.8(ii) to (v) , 'yes' has been mentioned . Thus as per para 12.1 and 12.3 any proposal for taking non forestry activity in protected area is required to be cleared by the standing committee of National Board for Wild Life (NBWL) under the provision of Wildlife (protection), apart from prior approval of Central Government under the Forest (Conservator), Act ,1980.	The proposal for wildlife clearance is under process with NBWL online vide proposal No.FP/HP/VELEC/1502/2017
11.	Against column No.9 (i) (ii) , Copy of NOC from Competent Authority , a PDF has although been uploaded but while viewing the said PDF , the same is not downloaded. Hence the revised NOC is required to be uploaded against this column.	Needful has been done.
12.	There is difference in district profile mentioned in online part-II and hard copy of Part-II. Necessary correction is required to be made in district profile.	Needful has been done.
13.	Against column No-16, instead of uploading the specific recommendation of DFO and CF concerned in the form of Part-II of DFO and Part III CF concerned, the forwarding letter have been uploaded.	Needful has been done.
14.	All the document placed in the proposal folder either should either be original attested one. Photocopies placed in the proposal folder should be attested either by user agency of DFO concerned.	Needful has been done.
