Inviting reference to the above mentioned subject, this is to inform you that reply of the point serial numbers 1, 2 are given below against the diversion of 13.5735 ha of forest land for construction of slop flattening in connection with Agartala- Sabroom new BG Line under District Forest Officer South Tripura.

1. i) The user agency submitted the proposal through online in the year 2017. And submitted the hardcopy of proposal vide letter No.W/207/Con/A-S/Forest land/ 2019/ 186 dt-04/06/2019, which was received by the District Forest Officer, South Tripura district on 07th June, 2019.
- ii) The user agency submitted a letter regarding withdrawing the proposal for diversion of the said land citing that the retaining wall work had already been constructed and there was no further requirement & the forest land for the purpose of slop flattening vide their no-W/207/Con/AGTL-Sabroom/Forest land/370 dated 24/08/2019.
- iii) Upon receipt of the letter for withdrawing the proposal for diversion of said forest land, the District Forest Officer South Tripura District physically verified the said forest land on 26/09/2019 and in his report to Asst. Conservator of Forests, FCA. vide letter no. F.4-48/DFO(S)/ Land/13.5753 ha/ Railway/ for-2019/ 6376-79 dated 09/10/2019, it was reported that the slop flattening work and retaining wall had already been done by the user agency without approval among other things.
- iv) Upon detection of the forest offence an OR was drawn against the user agency under Sec. 26(A) of IFA, 1927 read with subsequent amendments; and upon receipt of the compounding prayer by user agency vide No.F.W/Con/AGTL-Sabroom /Forest land/56 dated 27/05/2020, the offence was compounded by realizing a sum of Rs. 5000.00 as fine & Rs. 2.5 lakh as compensation for damage to forest land (all documents enclose).

v) The user agency started the slop flattening as well as retaining wall construction work on 04/06/2019 which was communicated to District Forest Officer South Tripura District by Asst. Executive Engineer /Cons. of N.F. Railway, Agartala vide letter No.F. W/207/Con/AGTL-Sabroom/Forest land on dated at 21/12/2021 and the said work had already been completed before 26/09/2020 on which the District Forest Officer South Tripura District went for physical verification.

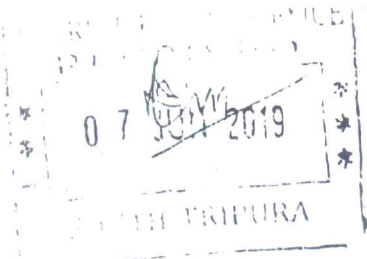

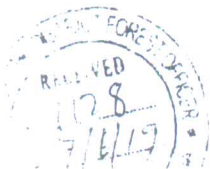

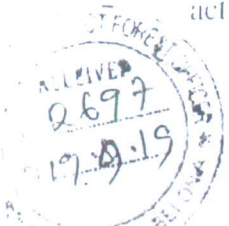

1. Slope flattening work all ready done by user agency along with retaining wall without prior approval.
2. The area was encroached with Rubber plantation, now it is free from encroachment.

Suggestion/Recommendation As user agency does not need the land anymore but however violation has been done, so if authority desires penalty may be imposed as per FCA violation. The same area can be reclaim with high density kanak kaich bamboo plantation, so reclamation cost may also be asked from the user agency.

GARDANG, CHHAY GHARIA AND KALABARIA MOUJA



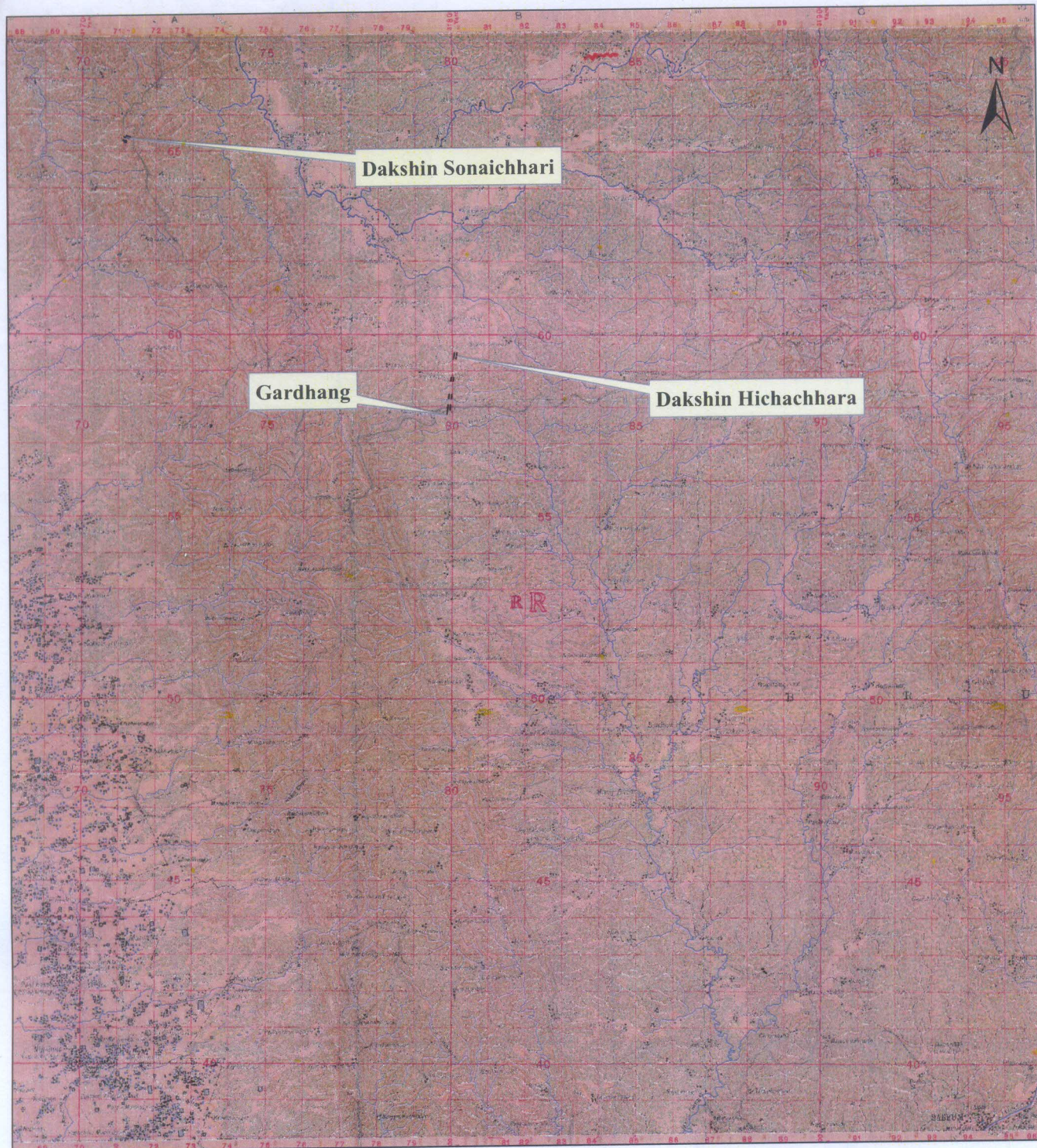

GARDHANG, DAKSHIN SONAICHARI AND DAKSHIN HICHACHHARA MOUJA



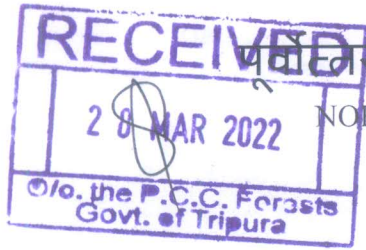

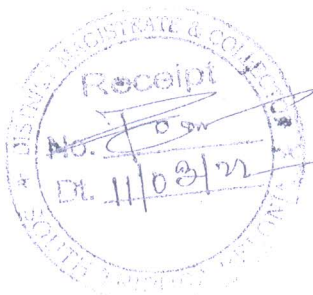


