QUARRYING LEASE OFSTONE/ROAD METAL FOR AN AREA OF 5.5 HECTARES IN LONGA KOIRENG, KANGPOKPI DISTRICT, MANIPUR TO BE GRANTED TO M/S. SHAMCHAND & SONS STONE CRUSHING CENTRE, IMPHAL WEST DISTRICT, MANIPUR.

PURPOSE WISE BREAK-UP OF THE PROPOSED LAND DIVERSION:

There is a high demand of stone/road metal in the State of Manipur for many developmental projects taken up by the State Government and many private sectors/companies for the development of the State such as construction of various types of roads, railway lines, irrigation canal, water supply projects, infrastructures, construction of Government buildings, private houses, etc. In the meantime, there is no legal quarry for supply of the above minor minerals. Therefore, these minerals can only be met from the proposed quarrying lease area with the protection of environment. Therefore, the diversion of the forest land for the proposed quarrying lease became necessary for meeting required minor minerals. In the mean time, to achieve the desired target, the following preventive measures shall be taken up as:

- 1. Only local skilled and un-skilled workers shall be recruited for quarrying of the proposed minerals.
- 2. Precautionary measures for using heavy machineries in the quarry to avoid untoward accident by providing appropriate training, repairing and maintenance of machineries will be taken up.
- 3. The approach road for transportation of minerals shall be properly maintained in good condition for utilization by the local villagers also.
- 4. The project proponent shall take up certain Programme such as distribution of school materials, organizing sport, health checked up, etc. in the nearby villages.
