Vide ref 39th cited, the Gol, MoEF & CC, New Delhi has sought additional information on the subject proposal for further consideration of the proposal.

Accordingly, vide ref 41st, 42nd cited, the General Manager (Estates), SCCL, Kothagudem Area, the Conservator of Forests, Bhadradi Circle has furnished information as desired by the Gol, MoEF & CC, New Delhi which are furnished as follows, with remarks:

Point No.i:-It is observed in DSS analysis that the State Govt. has provided the map showing location of 124 ha CA land for the instant proposal. Further, they have mentioned that out of 124 ha allotted CA, only 42.96 ha is available for instant proposal; rest CA area i.e. 81.04 ha is under encroachment by the local tribes. Therefore, in this regard the KML file of 42.96 ha and status of 81.04 ha encroached area is required. Moreover, the KML file of 124 ha area demarcated in the map wrt to CA and area for diversion (124 Ha) is not available. In this regard the State Government is requested to submit the revised KML file along with the map.

Reply:- The KML file of land free from encroachment of 42.96 Ha and KML file of encroached land of 81.04 Ha is enclosed.

The Maps and KML file of 124.00 Ha area w.r.t. CA land and area proposed for renewal diversion (FL) are enclosed.

Point No.ii:-Approval was accorded for the instant proposal on dt.08.02.1999 with a condition that the NFL transferred to SFD for CA shall be declared as PF/RF under IFA 1927. More than 23 years has been passed since approval but the identified CA land has not been declared as RF/PF. In this regard the State Govt. is requested to speedup the process of declaring the NFL identified for CA land and submit the copy of the notification declaring the non-forest land under section 4 or section 29 of the Indian Forest Act, 1927, or under the relevant section of the State Forest to this Ministry.

Reply:- The Principal Chief Conservator of Forests & HoFF, Telangana, submitted the notification proposals to the Special Chief Secretary, EFS &T, Hyderabad, vide reference No. 4750/2005/TG/WLR- Dt.30.07.2018 to an extent of 233.77 Ha and were returned by the govt with instructions to the submit revised proposals.

Meanwhile, DGPS survey was conducted for total area of CA land handed over and it was found there is shortfall of 23.77 Ha. In the available actual land of 210.00 Ha, there is an encroachment with the land allocation to the I &CADD department to an extent of 61.66 Ha.

The notification process could not be completed because of encroachment under influence of Naxal's problems in the area and it may not be possible to retrieve the encroached land. Hence, the proposal are being prepared for notification for the land which is free from encroachment to the state govt.

Point No.iii:- It has been informed that out of 124 ha earlier identified for CA only 42.96 ha is available for plantation and rest are encroached. It is pertinent to mention that the approval was accorded in 1999 and since then the CA plantation has not been carried out. In this regard the State Govt. is requested to offer its comments on the future plan for plantation in identified CA land that, whether the State is planing to remove the encroachment from the CA land or the State is identifying the fresh NFL for the purpose of CA land. In case of identification of the new NFL area by the State, the State Govt. is further requested to provide details, viz. KML file, Site Suitability Certificate, Revised CA Schemes, DGPS and Topo Sheet Map along with the progress wrt notification of the said land as RF/PF.

Reply:-

- a. It is submitted that the CA land of 124.00 Ha (part of 233.77 Ha.) was handed over to Forest Department in Sy.No.116 of Rasannagudem village of

Mulakalapally Mandal of erstwhile Khammam district on 06.03.1990 and the same was mutated in favour of Forest Department vide Mandal Revenue Officer, Mulakalapally Rc.No.B/912/97, dt.07.07.1997. The CA area was free from encroachment at the time of handing over and encroachments happened in subsequent years.

- b. CA scheme was prepared for taking up CA in 124.00 Ha for an amount of Rs.49,60,000/- and the SCCL has deposited the amount on 23.11.1998. Due to high density of tree growth existing in the said area, CA Plantation was carried out in alternate degraded Forest land identified in Compt.No.7 of Kondapur Block, Aswapuram Range, Paloncha Division in (4) bits.
- c. Out of CA land handed over, only area of 42.96 Ha is available (free from encroachment) and having good forest growth with more than 0.6 density as such no use of any further planting. The remaining area of 81.04 Ha is under encroachment and it may not be possible to evict the encroachments. Moreover, Compensatory afforestation has already been raised at alternate place at Aswapuram with the money deposited by SCCL.
- d. However, in view of urgency in grounding of the proposed project of VKOCP by SCCL, the SCCL has reported that the area found to be under encroachment and area allocated to the I & CADD department (81.04 + 61.66 =142.70 Ha), land may be apportioned from the **Non Forest land of 212. 04 Ha handed over** as land bank in Chunchupally, Wadaguda and Ramachandrunipeta villages(i.e. Rajupeta CA Block) of Mangapet Mandal. This land was handed over vide charge certificate dt.07.09.2007 and mutated vide Lr No.B/1452/2007 dt.07.09.2007 by Tahsildar. This land was initially intended to be given towards other projects of the SCCL, but it was not allocated to any project.
- e. This area (212. 04 Ha) was initially meant to be used for CA plantation for the project JVR OC -II for 776.20 ha of SCCL duly submitting the proposal to Moef for stage I approval. Meantime the SCCL was accorded CPSU status during 2013 by MOEF and accordingly while granting Stage I approval Vide File No 8-56/2014-FC dated 10-12-2014, MOEF stipulated condition no 2 (II) stating that the Forest department shall raise CA plantations over the degraded forest land (twice in extent) to the area of proposed forest for diversion at the cost of UA. This CA DFL was later on raised by the Forest department . The above mentioned area (212.04 hac) was however remained as land bank with Forest department. At present this area is having good tree growth and well protected.
- f. Out of this 212.04 hac area of NFL , KML files of 81.04 Ha and 61.66 Ha are

enclosed. It is requested to allocate 142.70 Ha. from this land bank towards compensating the land for 124.00 Ha proposal.

Point No.iv:- The State Govt. may also to offer its comments whether the plantation will be possible wrt the earlier approved CA scheme since there is lapse of 23 years.

Reply:-Earlier, the CA scheme was prepared for taking up CA in 124.00 Ha for an amount of Rs.49,60,000/- and the SCCL has deposited the amount on 23.11.1998. Due to high density of tree growth existing in the said area, CA Plantation was carried out in alternate degraded Forest land identified in Compt.No.7 of Kondapur Block, Aswapuram Range, Paloncha Divisionin (4) bits. Hence, the CA has been raised already in DFL , the forest department cannot insist UA again for raising CA in the newly allotted CA NFL identified in Mulugu division and further, the area is having good growth.

Point No.v:-With regard to overlap in the non-forest CA lands handed over by M/s SCCL and that handed over by I&CADD officials for SRLIP project it has been informed that District collector has been requested for allotment of alternate NFL area to an extent of 61.66 Ha in other location and the response in the matter is awaited. In this regard the State Govt. is again requested to identify the said land and forward the KML files, site suitability certificate, CA scheme details and relevant maps.

Reply:-

- a. In view of urgency in grounding of the proposed project of VKOCP, the SCCL has submitted the area found to be under encroachment and area allocated to the I & CADD department (81.04 + 61.66 =142.70 Ha) may be apportioned from the Non-Forest land of 212.04 Ha alreday handed over to Forest department as land bank in Chunchupally, Wadaguda and Ramachandruripeta villages of Mangapet Mandal and the land was handed over vide charge certificate dt..07.09.2007 and mutated vide Lr No. B/1452/2007 dt.07.09.2007 by Tahsildar.
- b. At present this area is having good tree growth and well protected.
- c. Proposals are submitted to the PCCF for notification by the District Forest Officer, Mulugu,vide his reference No. 800/2022/TS Dt 10.01.2023 for the alternate land handed over as land bank.

Point No.vi:-The State Govt. may also clarify the validity of the mining lease with regard to instant proposal.

Reply:- M/S.SCCL gas stated that the proposal of 124.065 ha proposed for renewal of diversion is falling in Kothagudem Mining Lease (2nd renewal), which was granted by the State Government for an extent of 5158 Ha (involving 1466 Ha of Forest land) vide Go.Ms No 324 dt.12.12.2008. **This lease is valid upto 26.04.2029**. Copy of GO issued by the State Government is enclosed.

Point No.Vii:-Further, provisions as per para 1.21 (iii) of the Comprehensive guidelines issued by this Ministry 2019, Violation/Non-Compliance of any conditions imposed while granting approval under FC Act 1980 are applicable in the instant case as there is non-compliance of the conditions stipulated in the approval granted. State Govt. may offer its comments in this regard.

Reply:- M/s.SCCL has complied with all the stipulations in the earlier Stage-II accorded for this project and submitted the compliance report to the District Forest Officer, Kothagudem and Conservator of Forests, Bhadradi Circle. The Conservator of Forests, Bhadradi Circle has also submitted the compliance report to the Principal Chief Conservator of Forests & Nodal Officer, TS. (Copy enclosed). Further, SCCL has not carried out any violation under the F (C) Act.

In view of the above facts and circumstances, the State Government are requested to forward the above comments to the MoEF& CC, Government of India New Delhi duly recommending the alternate Non-Forest land of 124 hac (in lieu of encroached forest and overlapped land) for consideration while processing the proposal and accord necessary approval to this proposal .

ORDER:

In the reference 1st and 2nd read above, Government have granted 1st Renewal of Mining Lease for Coal over an extent of 61.17 Sq.Kms. (includes 23.38 Sq.Kms. forest land and 37.79 non-forest lands) of Kothagudem area of Khammam District for a period of 10 years w.e.f. 28-04-1999 to 27-04-2009.

- 2) In the reference 4th read above, the Director of Mines and Geology has sent proposals for grant of 2nd Renewal of Mining lease for extraction of Coal over a reduced extent of 5158 Hectares involving 1466 Hectares of forest land and 3692 Hectares of non-forest land in Kothagudem Mandal, Khammam District, in favour of M/s Singareni Collieries Company Limited, for a further period of 20 years from 27.04.2009 to 26.04.2029, subject to obtain prior approval of Govt. of India under Section 5(1) and relaxation of Section 6(1) (b) of M.M.(D&R) Act,1957 and the Clearances from MoEF, under Forest (Conservation) Act, 1980 and subject to satisfaction of terms and conditions of MM (D&R) Act, 1957 and M.C. Rules, 1960.
- 3) In the reference 5th read above, State Government have proposed for grant of 2nd Renewal of Mining Lease for extraction of Coal over a reduced extent of 5158 Hectares involving 1466 Hectares of forest land and 3692 Hectares of non-forest land in Kothagudem Mandal, Khammam District, for a further period of 20 years from 27.04.2009 to 26.04.2029 in favour of M/s Singareni Collieries Company Limited and accordingly addressed the Ministry of Coal, Government of India.
- 4) In the reference 6th read above, the Ministry of Coal, Government of India, have conveyed their prior approval for grant of 2nd Renewal of Mining Lease for extraction of Coal over a reduced extent of 5158 Hectares involving 1466 Hectares of forest land and 3692 Hectares of non-forest land in Kothagudem Mandal, Khammam District, for a further period of 20 years from 27.04.2009 to 26.04.2029 under section 5(1) (b) and also in relaxation under Section 6(1) (b) of M.M. (D&R) Act, 1957 since the total area of the Mining Lease granted so far exceeds 10 Sq. Kms. in the interest of development of the minerals.
- 5) Government, after careful examination of the matter, hereby grant the 2nd Renewal of Mining Lease for extraction of Coal over a reduced extent of 5158 Hectares involving 1466 Hectares of forest land and 3692 Hectares of non-forest land in Kothagudem Mandal, Khammam District, for a further period of 20 years from 27.04.2009 to 26.04.2029, in favour of M/s Singareni Collieries Company Limited subject to satisfaction of terms and conditions laid down in MM(D&R) Act, 1957 and M.C.Rules, 1960, subject to submission of Consent for Establishment from Andhra Pradesh Pollution Control Board, Environmental clearance from Ministry of Environment & Forests under Environment Impact Assessment as per S.O.No.1533, dt.14-09-2006 and also Forest Clearance under Forest (Conservation) Act, 1980 by Ministry of Environment & Forests before execution of lease deed and also subject to the satisfying conditions in Form-K prescribed under the M.C. 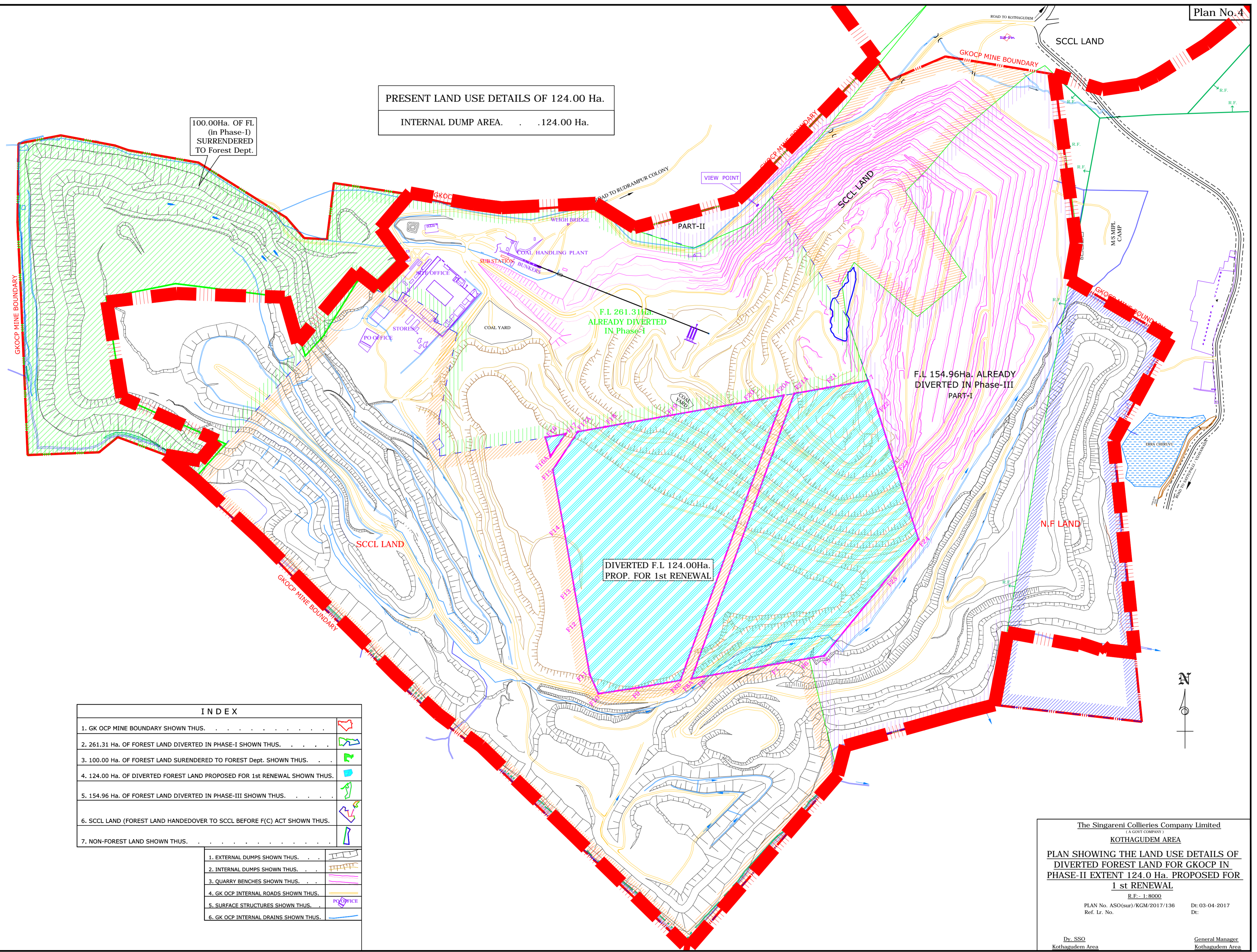

Adverting to the reference 2nd cited above, the District Forest Officer, Bhadradi Kothagudem has submitted that, the General Manager, Singareni Collieries Company Limited, Kothagudem Area has submitted the condition wise compliance report on Stage-II approval accorded vide reference 1st cited for diversion of 124.00 Ha of Forest land for OCP (GKOC) Phase-II, Kothagudem in Ramavaram RF & Range of Kothagudem Division of Bhadradi Kothagudem District (Erstwhile Khammam District) in favour of M/s. Singareni Collieries Company Ltd., Kothagudem Area, the same is submitted herewith as follows after the field inspection of the undersigned.

Condition No.(1): Legal status of the forest land shall remain unchanged.

Compliance: The legal status of land remains as Reserve Forest.

Condition No.(2): Compensatory Afforestation shall be raised over equivalent non-forest land at the project cost.

Compliance: The SCCL has handed over non-forest land of 124 Ha to the Forest Department on 06-03-1990 towards CA. This land is part of 495.08 Ha situated in Sy.No.116 of Rasannagudem (V) , Mulakalapalli (M), Paloncha Forest Division and handed over to the Forest Department. The SCCL has paid Rs.49,60,000 to the Divisional Forest Officer, Paloncha on 23-11-1998 towards CA charges. The SCCL paid cost of CA (124.00 Ha.) amounting to Rs.49,60,000/- vide Cheque No.32932, dtd.23.11.1998. Further, the State Government vide letter No.15050/For.1/97-7, dtd.08-01-1999, confirmed the above CA land, while forwarding the proposal to MoEF, Gol.

Due to high density of tree growth in the area (NFL) already handed over to Forest Dept., alternate degraded Forest land of 124.00 Ha., suitable for raising plantation was identified and taken up planting as detailed below in Aswapuram Range of erstwhile Paloncha Division now in Manuguru Division of Bhadradri Kothagudem District. Due to bifurcation of divisions and circles records are not available for identifying exact locations.

The MoEF&CC, Gol vide Lr.No.8-17/1998 FC (Vol), dt.01.05.2023 has informed that 61.66 ha. is overlapping of CA area of SRLIP and 81.04 ha under encroachment at this stage the SCCL has submitted herewith an under taking to handover 142.70 (81.04 Ha encroached & 61.66 Ha overlapped) at Mangapet Range of Mulugu district.

Condition No.(3): Demarcation of mining lease area will be done on the ground with RCC pillars with serial number and bearing and distance from pillar to pillar at the project cost

Compliance: Since the mining lease area is for the open cast quarry purpose, the entire area of 124.00Ha has been de-coaled this has disturbed all pillars in the Opencast mining, as the project is surrounded by other opencast mines which are continues, hence In the area filled with over burden 14 nos. pillars had been constructed (KML attached). Out of 28 pillars, only 14 pillars are seen.

Condition No.(4): The non-forest land transferred to Forest Department for Compensatory Afforestation shall be declared protected forest/reserved forest under Indian Forest Act, 1927.

Compliance: The SCCL has already handed over the Non-forest land measuring 124.00 Ha. in Rasannagudem (V) to the Divisional Forest Officer, Paloncha on 06.03.1990. This area forms part of total area measuring 495.08 Ha. of Non-Forest land in Sy.No.116 of Rasannagudem (V) of Mulkalapally Mandal, which was handed over to Forest Department towards CA land for various projects of SCCL. Out of the total area of 124.00 ha handed over for this project an area of 81.00 Ha is under encroachment and an area of 23.77 ha was falling short after the survey, accordingly an equivalent area of 23.77 Ha has been identified by SCCL authorities at JKOC-2 OB dump in Khammam District of Singareni Mandal (Reference attached). Further it was observed that an area of 81.00 ha is under encroachment before 2005 by local tribes (Report of DFO, Bhadradi Kothagudem District attached). Accordingly the SCCL has given undertaking for providing alternative non forest land at Mangapet of Mulugu District (Undertaking attached). Notification was not taken up due to above mentioned issue.

Condition No.(5): The User Agency will transfer funds for fencing, protection, regeneration of safety zone area and also the cost of afforestation over one and half time of the safety zone area degraded elsewhere in favour of Forest Department

Compliance: An amount of Rs.3.66 lakhs was paid to Divisional Forest Officer, Kothagudem on 23.11.1998 towards plantations in safety zone area and afforestation in 1½ times of safety zone area. Safety Zone area for 124 Ha. cannot be maintained as the area is in the middle of the Quarry. However Safety Zone area is maintained around the project. (KML & Plan attached).

Condition No.(6): Reclamation of mined area will be done as per the approved plan at the cost of User Agency. Soil conservation and afforestation work around OB dump area should be carried out to control soil erosion from that area.

Compliance: The entire area was de-coaled by open cast quarry. Now this void area is proposed for dumping of over burden from the proposed VK CM (Venkatesh Khani CM) and accordingly revised Mining Plan (copy enclosed) got approved from the MOC vide reference No.38077/12/2017-PCA, dt.12.09.2019. The reclamation of this area will be taken up as per revised approved mining plan. As on date about 65Ha Plantation is done on over burden dump and 59 Ha is void. Further, it is to note that the plantation done on 65 Ha will be damaged for VKCM (fresh mine) dumping operation and total plantation (124Ha.) will be done in 20th year (i.e.2043) as per the revised approved mining plan of VKCM.

Condition No.(7): OB dump and mined out area of Phase-I will be reclaimed by the user agency within next one year and plantation will be taken up and report in this regard will be submitted to this office and Regional Office at Bangalore.

Compliance: SCCL vide letter No. GMK/ASO(SUR)/ 61A/2K/96 dated 11.04.2000 requested GOI for deletion of condition (7), as it is not in consonance with condition No.6 and the GOI vide letter No. 8-17/98-FC, dated 01.01.2002 amended and communicated the same to read as " in a phased manner as per approved Reclamation Plan" instead of within next (1) year.

The reclamation is being done as per approved EMP and approved plan of VKCM. A Half yearly Environmental Monitoring report is regularly submitted to The Director, Regional Office, MoEF&CC Hyderabad. The recent report (April-2022 to September-2022) was submitted vide Lr.No.KGM/ENV/401/160, dtd 26.11.2022. Coal excavation was completed in the year March,2019. Dumping of OB in under progress in 83.98 Ha and balance 40.02 Ha. Will be completed by the end of year 20th year (i.e.2043) as per approved VKCM mine closure plan. Further it is noticed that the mining closure plan of VKCM will be implemented for this project instead of GKOC (124.00 Ha opencast is part of GKOC), for which mine closure plan is approved by MOC in the year 2020 and is valid till 2040 (Mine closure plan approval vide GOI Ministry of Coal File No. PCA-38011/12/2017-PCA, dt: 27.01.2020 attached)

Condition No.(8): The lease period will be for 20 years.

Compliance: The lease period is for 20 years. The renewal proposal was submitted well in advance on 28-03-2018 by SCCL and State Government vide letter No.1069/For.I/2019, dtd.29-10-2019 has forwarded the proposal to MoEF&CC, Gol, recommending for renewal. Mining Lease under MMDr Act is valid up to 26.04.2029.

Condition No.(9): The user agency will provide free fuel wood to labour and staff working at the project site so as to avoid any pressure on adjoining forest land

Compliance: The SCCL is providing LPG to all its employees at free of cost @ 12 cylinders per annum.

Condition No.(10): Proper drainage pattern should be provided and maintained in the project area.

Compliance: The total diverted area was meant for Mining (Quarry) operations. The total drainage over the surface was broken up and the water flowing on the surface was impounded in void. There was no major/minor stream over the surface.

Condition No.(11): The SCCL should not burn on coal at the project site as well as project for manufacturing soft coke or household coke

Compliance: Coal burning is not taking place in SCCL for making soft coal.

Condition No.(12): This approval is subject to Environment Clearance under Environment (Protection) Act.

Compliance: MoEF vide letter No.23-254/2018-IA.III (V), dt.20.05.2021 and accorded Environmental Clearance for GKOC (Copy attached).

Condition No.(13): Any other condition that the State Government may impose from time to time for the protection and improvement of flora and fauna in the forest area

Compliance: No other condition was stipulated. The SCCL will abide with any condition if imposed in future.

In this regard, the District Forest Officer, Bhadradi Kothagudem has requested to forward the compliance report on Stage - II approval to the Prl.Chief Conservator of Forests (HoFF), Telangana, Hyderabad for further action.

Therefore, based on the report of the District Forest Officer, Bhadradi Kothagudem, compliance report on Stage - II approval for the above project is submitted to the Prl. Chief Conservator of Forests (HoFF), TS, Hyderabad in (04) sets for taking further action in the matter.

Condition No.(4): The non-forest land transferred to Forest Department for Compensatory Afforestation shall be declared protected forest/ reserved forest under Indian Forest Act, 1927.

Further it is noticed that the mining closure plan of VKCM will be implemented for this project instead of GKOC (124.00 Ha opencast is part of GKOC), for which mine closure plan is approved by MOC in the year 2020 and is valid till 2040 (Mine closure plan approval vide GOI Ministry of Coal File No. PCA-38011/12/2017-PCA, dt: 27.01.2020 attached)

Condition No.(8): The lease period will be for 20 years.

Compliance: The lease period is for 20 years. The renewal proposal was submitted well in advance on 28-03-2018 by SCCL and State Government vide letter No.1069/For.I/2019, dtd.29-10-2019 has forwarded the proposal to MoEF&CC, GoI, recommending for renewal. Mining Lease under MMDr Act is valid up to 26.04.2029.

Condition No.(9): The user agency will provide free fuel wood to labour and staff working at the project site so as to avoid any pressure on adjoining forest land.

Compliance: The SCCL is providing LPG to all its employees at free of cost @ 12 cylinders per annum.

Condition No.(10): Proper drainage pattern should be provided and maintained in the project area.


