Sub:- Proposal for non-forestry use of 349.709 ha of forest land within total mining lease area of 2290.449 ha in Siarmal Open Cast Coal Mining Project by Mahanadi Coalfields Ltd. (MCL) in Sundargarh District, Odisha.

Sir,

In inviting a reference to the Government of India, MoEF & CC, New Delhi letter cited above on the captioned subject, it is revealed from DSS Analysis of 712 ha degraded forest land identified for CA in Satparlia RF that MDF is 130 ha and water body is 1.00 ha which amounts to 581 ha (712 ha – 131 ha) plantable in the Satparlia RF. Another patch in Jamkani RF over 129 ha has been identified which will meet the requirement of twice the extent of forest land proposed for diversion excluding the safety zone area i.e. 345.779 ha (349.709 ha – 3.93 ha). The KML file is sent herewith for kind information and necessary action.
