



Accordingly justification for adopting the alignment and proposed land widths for diversion etc.., are submitted and the meeting  $5^{\text{th}}$  cited is attended to by the representatives of the

Regarding the observations from a) to f) made during the inspection 3<sup>rd</sup> cited, the observations a) and b) are attended before the REC meeting and are covered in the SIR under 3C and 3D and are accepted in the meeting 5<sup>th</sup> cited. Regarding observation c) the No Objection certificate obtained from the Manager/CAO, Power Grid Corporation of India dated 15-12-2018 is herewith enclosed.

Regarding observation d) The Chief Engineer (Projects) & DWRO, Water Resources Department, Kadapa has requested the Government of Andhra Pradesh to obtain from the Government of India for extension of Environmental Clearance up to 30-06-2024 vide letter 6<sup>th</sup> cited and soon after the receipt the same will be communicated.

Regarding observation e) Provision for canal bank plantation is made in the estimate and the same will be taken up during the course of execution and Regarding observation f) as the canal is linear the issue of CAT plan does not arise and the same opinion is agreed to in the REC meeting.

In view of the above it is requested that Stage – I clearance may be obtained and communicated for this proposal at an early date. Further it is to submit that this package is under prioritized list of the projects in Andhra Pradesh and being reviewed by the Honourable Chief Minister of Andhra Pradesh.
