Subject: - Diversion of 12.9880 ha. of forest land in favour of M/s GEE CEE Hydro Power Pvt. Ltd. VPO Sarahan Tehsil Rampur, Distt. Shimla H.P for the construction of Kot Dogri SHEP (10 MW) within the jurisdiction of Rampur Forest Division, Distt. Shimla H.P.

Kindly refer to your office Endst. No.1602 dated 04-07-2020 on the subject cited above.

2. As desired, the point-wise reply to shortcomings as pointed out by the Nodal Officer-Cum-Addl. Pr.C.C.F. HP in the instant case is furnished as under:-

1. The legible copy of Geo-referenced map is now uploaded by the user agency against online para C (iv).  
2. FRA certificate is in process and an undertaking regarding FRA certificate is already placed in the proposal by user agency and also uploaded in online portal.

3. User agency has submitted that the signing of fresh Implementation Agreement for the enhanced capacity of 10MW is in process and will submit it before Final Approval.

4. In this regard the user agency has submitted the letter issued from Pr.C.C.F.W.L & C.W.L.W. H.P. in which he has mentioned that the project site is located at the distance (aerial) of 3.153 Kms from Rupri Bhaba Wildlife Sanctuary.

5. In this regard the user agency has submitted the letter issued from Pr.C.C.F.W.L. & C.W.L.W. H.P. in which he has mentioned that there is no requirement of animal passage plan for the construction of project.

6. In this regard the user agency has submitted that as per letter issued from Pr.C.C.F.W.L & C.W.L.W. H.P. in which he has mentioned that there is no requirement of animal passage plan for the construction of project. Hence, there is no need for correction at para 8 (iii) in online portal.

7. It is submitted that all the govt. waste lands in this district are considered as forest land in view of the 1952 notification of Govt. of H.P. which has declared all Govt. waste land as Protected Forests. Hence there is no availability of suitable non forest land within the jurisdiction of Rampur Forest Division, Rampur for raising of compensatory afforestation. In this regard a certificate jointly signed by D.C. Shimla and D.C.F. Rampur is already placed in proposal folder and also uploaded in the online portal.  
8. KML file of CA is now uploaded in online portal

9. In this regard previously the user agency has taken 1.0599 ha. area for diversion having all components excluding area under transmission line corridor now enumeration list of trees of all components including transmission line has been uploaded in online portal.

10. This pertains to higher office.

11. In this regard spot inspection has been done by the undersigned and found that the proposed diversion area does not comprise Very Dense Forest. Certificate in this regarding enclosed.

12. The Transmission line is now shown in Para C (iv) of part-I in online portal also submitted hard copy by the user agency. Transmission line is also now shown in SoI Toposheet at para C (iii) in online portal also submitted hard copy.

13. The user agency has now shown transmission line in KML file and uploaded at para-C-of part-I.

14. The necessary correction has been done.

15. The necessary correction has been done.

16. The breakup of 12.988 ha. (surface land and underground land) area is enclosed and the surface rights over the underground land is proposed by the user agency.
