The user agency has intimated that the Bhanupali-Bilaspur-Beri New Rail line is a linear project for 3(a) which the proceeding of Gram Sabha are exempted. Similar precedence has been followed in previous proposals in the project. The user agency has intimated that the SDO(C)-cum-Chairman, FRC vide office order No. 3(b) BLS.SDM.FRC.2022-2183 dated 28.03.2022 after conducting necessary meetings has mentioned that:-

It is clear that no claim has been filed before the FRC nor any such claims are (i)

pending for disposal before Gram Sabha. (ii)

No petition has been filed before SDLC by any person aggrieved by the resolution of Gram Sabha.

Subsequently, the chairman SDLC has mentioned that the objections are not tenable, and NOC under FRA has been issued by SDLC and DLC.

The user agency has intimated that the components including beneficiary villages marked in distinct colors have been attached as soft copy as part of proposal file. 5
