Kindly refer to your online EDS No Ft.48-3453/2015 (FCA) dated 16.06.2023 on the subject cited above.

In this context, the annotated reply of the observations/EDS pointed out vide communication referred to above is as below: -

1.	The working plan prescription in part-II is still not corrected. As per the document uploaded against the addl. Information detail column the proposed area seems to be fall in Chil working circle, the working plan prescription be revised/ corrected	In this context, it is submitted that the forest land involved in this case is designated as UPF Badoi C1 and allotted to Chil Working Circle PBU wherein protection against fire has been prescribed in the Working Plan of Hamirpur Forest Division
2.	The complete CA scheme giving the technical detail of the CA scheme has still not been provided and CA scheme, digital map and KML file may be uploaded against the appropriate column of Part-II and the status of the proposed CA area may be provided whether it is a waste land notified as PF under 1952 Notification or notified PF as per IFA, 1927	It is context, it is re-submitted that CA Scheme is proposed as block plantation for which no option is available in the web portal. The CA has been charged with regards to per plant cost. Hence the CA Scheme alongwith Bill, DGPS Map, toposheet is uploaded against the additional information and KML file will be uploaded on e-green watch web-portal after Stage-I approval since no option is available for the same. Further the Forest Land Proposed i.e. P 11 Sathwin is Demarcated Protected Forest (DPF) and is notified PF under IFA 1927
3.	The NPV and Penal NPV bill are still not revised as per the latest rates prescribed by Gol.	In this context, the bill of NPV has been updated against the additional information in online part II. However the same already stands submitted vide this office letter no. I/307551/2023 dated 28.12.2023 in EDS reply.
4.	The detail in para 11 of part-II may be filled completely, against the para 11 (1) (b), 12 has been mentioned whereas, year of the violation are to be mentioned further, the detail at para 11 (i) (c) of Part-II be filled even though the present proposal is in the	It is context, it is submitted that Proposed road is constructed by HPPWD in the year 2007 and is also listed in the list of roads constructed in violation in CWP No. 5600 of 2012 dated 05.09.2013 titled as Sh Manoj Kumar Vs Charan Vs UOI and others” linked the COPC No. 56 of
