In reference to your office no. mentioned above, it is submitted that the user agency originally applied for diversion of 0.73 Ha. Forest Land in the instant case. But, the National Board for Wildlife in EDS dated: 22-02-2021 advised to shift one dumping site outside the Forest land in the said proposal for Wildlife Clearance.

Accordingly, the user agency vide his letter No. PMGSY/Div./ Rgr/360-62 dated: 03-05-2021 has also clarified that after the shifting of dumping site-2 from RD 1/000 having an area of 0.25 ha from forest land to non-forest land at RD 1/050, the forest land has been reduced from 0.73 ha to 0.48 ha.

Hence, it is submitted that only 0.48 Ha. Forest land is proposed for diversion for construction of Road from Sumwal to Sarail Choa under proposal FP/JK/ROAD/46670/2020.
