- The pointwise reply to the observations as raised vide your above referred 2 communication is submitted as below:
 - 1. In this context, it is submitted that the alignment of Thaltukhod Stage-II HEP falls in two Panchayat i.e. Dhamchayan and Tarswan Panchyat. The project component such as Trech Weir, Desilting Chamber, Approach pipe line up to tunnel portal and also of tunnel falls under Kharyan village and approach road to Power House alongwith some portion of the transmission line comes under the Cheling village area. Both villages falls under the jurisdiction of Dhamchayan Panchayat. Further, Mathibajggan village falls under Tarswan Panchayat which is the last village of this Panchayat. After the boundry of this village ends, second Panchayat starts. The tunnel, edit of tunnel, Forebay Penstock, Power House, Seitchyard and Tail Race Channel of project, all falls in Mathibahgaan village of Tarswan Panchayat. Therefore, Kharyan, Mathibajgaan and Cheing villages are shown as beneficiary villages.
 - 2. The component wise breakup area of dumping site IV & V and bridge has been prepared by the user agency and is enclosed herewith.
 - 3. The name of the surrounding area is Tikkan but the main Power House site of Thaltukod Stage-II HEP falls under the jurisdiction of Mathibajgaan village
 - 4. The area of Transmission line in forest land and private land alongwith evacuation plan has been prepared by the user agency and uploaded in the additional information detail of Part-I. The hard copy of the same is enclosed herewith.

- 5. The scientific names of trees in the proposed forest land for diversion has been uploaded in the online Part-II against column No. 4(ii) and enclosed herewith.
- 6. The details of trees to be felled or not to be felled out of 197 trees have been prepared and abstract of the same has been uploaded in additional information detail in Part-II. The hard copy of the same is enclosed herewith. Enumeration list of trees in area proposed for muck dumping has also been prepared and enclosed herewith. The abstract of the same has been uploaded in additional information detail in Part-II.
- 7. In this connection, it is submitted that the non forest land is not available in The non-forest land, the nearby vicinity of the project component. whichever is available has already been acquired by the user agency for housing the project components. The necessary confirmation is enclosed herewith regarding non-availability of non forest land for dumping the muck excavated as given by revenue authority and other concerned authority.
- 8. The letter of Director of Energy is enclosed herewith.
- 9. The user agnency has intimated that the IA and TEC is under process and submitted an undertaking that he will submit the same before the final approval of the case. The undertakings are enclosed herewith.
