1.	FRA is not provided for Hisar & Fatehabad Divisions, same may be provided duly countersigned by DFO concerned.	Except Fatehabad Division, FRA Certificates have been uploaded on portal.
2.	CA Scheme provided by the State Government for plantation of tall plants in all three divisions and the maintenance charges (10 years) for per plant is taken as in Jind Division as Rs.888.15; in Fatehabad Division it is taken as Rs.713/- & in Hisar Division, it is taken as Rs.526.67. Justification needs to be submitted for taking different charges for the same type of plantation scheme/Soil type.	As per revised cost norms dated 15/05/2023 revised CA schemes have been uploaded by all three divisions.
3.	CA scheme needs to be rationalized, as the Wild Life habitat charges, Forest guard hut, Patrolling Vehicle Mahindra Scorpio, Protection Watcher charges are included in Hisar Division CA scheme.	Revised CA schemes have been uploaded by Hisar after excluding Wild Life habitat charges, Forest guard hut, Patrolling Vehicle Mahindra Scorpio, Protection Watcher charges
4.	In Fatehabad Division, the total area of KML proposed is approx. 77.59 (ha.) out of it 18.46 ha area is available which is not sufficient for the target plantation of 23858 plants, needs to be provided additional 5.398 ha. area as per 1000 plants/hectare model. In addition, details uploaded in part-II at 13(ii) & in land suitability certificate is not matched, needs to be uploaded the revised land suitability certificate at 13(ii).	KML file and DGPS map of for additional 5.398 ha. area as per 1000 plants/hectare model have been uploaded and the same have also been checked by GIS Analyst In addition, CA details has been corrected in part-II at 13(ii) & in land suitability certificate.
5.	In Hisar division, only 2.21 ha area is available & i.e. not sufficient to plant 35,580 plants. Need to revise DGPS map pdf of CA site named Jakhal Hisar Railway Line Km 62-75 L&R or KML because both of them are not matching with each other. In addition, details uploaded in part-II at 13(ii) & in land suitability certificate is not matched, needs to be uploaded the revised land suitability certificate at 13(ii).	DFO, Hisar has informed that now, Rewari-Bhatinda Railway line has been identified for proposed CA. Accordingly, land suitability certificate and KML file file/DGPS map of CA site have since been uploaded on portal.
6.	In Jind division, details uploaded in part-II at 13(ii) & in land suitability certificate is not matched, needs to be uploaded the revised land suitability certificate at 13(ii).	Corrected/uploaded on portal.

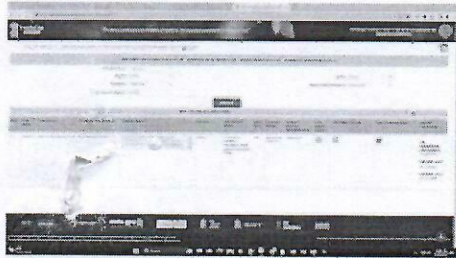

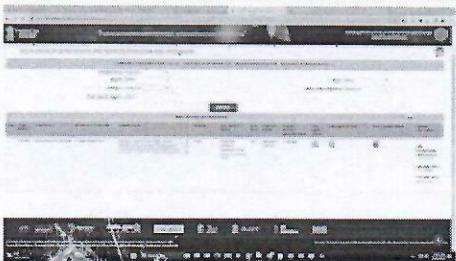
