With reference to the Government of India letter cited, I wish to inform the following.

- i) 54 proposal approval accorded under State Government General approval category have to be uploaded. As the above 54 proposals, some are found to be very old, details have to be collected from the closed records and it has to be scanned (as it is a lengthy process ie., for one file, minimum 20 to 30 pages are to be scanned) and then uploaded. The uploading work is under progress. Out of 54 proposals, details have been uploaded for 25 proposals and updating is under progress. For the balance 29 proposals, collection of old records is in progress and work will be completed soon.
- ii) On the uploading of 24 listed proposals, updating work is under progress. Out of 24 proposal, details have been uploaded for 15 proposals and the remaining proposals, work will be completed soon.

Reconciliation of FC cases cleared after 1980 namely details on Annexure I iii) and II compilation work is under progress. For this, details have to be collected at field level and continuous action is being taken to complete the work at the earliest.

Further, I wish to inform that, updating of old cleared proposals (approval accorded under General category and FC cases cleared after 1980) is a continuous process and required details will be uploaded then and there.

Hence I request that, the present proposal may be cleared since the User Agency - Highways Department has to carry out the bridge reconstruction work for the welfare of people after obtaining due approval.
