I submit that with reference to Principal Chief Conservator of Forests's reference 4th cited, the following particulars / details as received from the District Forest Officer, Dharmapuri are enclosed for kind perusal and follow up action;

- (i) Copy of Compensatory Afforestation Scheme estimate in duplicate
- (ii) Site inspection report of the Compensatory Afforestation Land by the District Forest Officer, Dharmapuri in duplicate

I submit that the above details have been uploaded in the designated web portal.

I submit that the District Forest Officer, Dharmapuri in his report in the reference 5th cited has justified the need for engaging a separate protection mazdoor for 3 years instead of 7 years as proposed earlier. The District Forest Officer has also justified the need of providing chain link fencing taking into consideration of Wildlife menace in this area for the protection of proposed plantation area. The components of works proposed for Chain link fencing are absolutely necessary.

Therefore, under the circumstances I request that the report of the District Forest Officer, Dharmapuri and the Compensatory Afforestation Scheme including chain link fencing and provision of protection mazdoor may kindly be considered and the proposal recommended to Government accordingly.
