ĵ.	Check list Page No.	The Page Numbering in the checklist has been done and the same is enclosed in the Forest Diversion Proposal.
2	Land Schedule of the forest Land	The Land Schedule of the Forest land involved in the project has been corrected and authenticated by the concerned Forest Range Officer and Tahsildar. The same has been enclosed in the Diversion Proposal as Annexure-In.
3	Land Schedule of the Non- Forest Land & other Kissam Forest Land	The Land Schedule of the Non- Forest land and other Kissam Forest Land involves in the project has been corrected and authenticated by the Tahasildar and the same has been enclosed in the Diversion Proposal as Annexure-III.
4	Dimension of the Road	The length & width of the proposed Road in R.F/DPF/DRF, Revenue/other Forest (Jungle Kisam). Non-Forest Govt and Private Land has been calculated and the extent of the area involved in category has been enclosed in the Diversion Proposal as Annexure-IX.

5	Tree Enumeration	The typographical mistake has been corrected and the enumeration list has been corrected and showing the trees involved in the R.F/PRF/DPF and other forest (Revenue Forest/Jungle Kissam) has been indicated in the existing list of the trees enumerated after field verification. 7	C.A. Allocation & C.A. Scheme	Degraded Revenue Forest Land to a tune of 45.996 Ha was identified & allotted in village Dupi & Guma Under Tumudibandha Tahasildar of Kandhamal Dist. Out of 45.996 Ha. of Degraded Revenue Forest Land 15.702 Ha. was earmarked in village Guma Vide Khata No.81 and Plot No.30 & 31. Accordingly, the Map and C.A. Scheme was prepared. Further 2.794 Ha. of Jungle Kissam Land identified in village Balliguda to Compensate the short fall land. The detail Map and Land Schedule are enclosed in the Forest Diversion Proposal at Plate No. IV, IV(A), IV(B) & IV (C).
