It is submitted that, in the reference 3rd cited, the Government have stated that, para 4.4 of Chapter-4 of comprehensive guidelines issued by Gol, MoEF &CC, New Delhi in F. no. 5-2/2017-FC, dated: 28.03.2019 related to General approval for public infrastructure projects in LWE Districts has expired on 31.12.2020 and therefore, exemption of provision of CA for such projects is not applicable presently and requested that non-forest area for compensatory afforestation may be identified and the details of the same may be submitted including map, DGPS co-ordinates, KML file, CA scheme, site suitability certificate etc. for further consideration of the proposals.

The Executive Engineer, Panchayat Raj(PIU) Division, Vizianagaram has identified non-forest land to an extent of 25.85 ha in survey no.108 of Pedakhandepalli village, S.Kota Mandal, Vizianagaram for the following (10) road proposals which includes the present proposal for CA purpose to have single patch and to enable the Forest Department to effectively manage the newly planted area.

As per para 2.8 of Chapter-2 of Comprehensive guidelines issued by the Government of India, MoEF &CC, New Delhi in F.No. 5-2/2017, FC, dated: 28.03.2019, out of above (10) projects, the District Forest Officer, Vizianagaram has prepared CA scheme proposals for 14.35 ha (single patch involving CA area for 5 projects at sl.no.1 to 5 above) with a financial outlay of ₹107.641 lakh. Out of 5 projects, the CA scheme for the subject proposal (sl.no.1) for diversion of 4.36 ha forest area is arrived on proportionate basis is ₹27.64 lakh for a period from 2022-23 to 2033-34 with 10 years of maintenance. The CA Scheme, map and other related certificates are submitted herewith. Remaining (5) proposals mentioned at Sl. no. 6 to 10 are at initial stage and not yet received by this office.

Further, the District Forest Officer, Vizianagaram has inspected the nonforest land offered by the User Agency for Compensatory Afforestation purpose on 05.11.2021. Site inspection report of the District Forest Officer, Vizianagaram has been uploaded at Nodal Officer level.

Government are requested to take necessary action for onward submission of the proposal to the Government of India, MoEF &CC, IRO, Vijayawada to accord forest clearance under Section-2 of Forest (Conservation) Act, 1980 and amendments therein.

The Chief Conservator of Forests, Visakhapatnam has approved the C.A. scheme for the above said (5) roads in Rc.No.1920/2020/TO, dt: 11.03.2022.

The District Collector, Vizianagaram in Rc.No.3384/2021/D1, dt: 27.11.2021 has agreed for alienation of the above said C.A. land 16.98 hectares to the Forest Department. (Copy of the District Collector, Vizianagaram letter is enclosed herewith).

The user agency has also given undertaking to raise the strip plantation on both sides and central verge of the road as per the IRC norms as per Part-C (G) (9) of hand book guidelines issued by the Government of India, M.o.E.F.& C.C, New Delhi letter No.5-2/2017-FC, dt: 28.03.2019.
