Kindly refer to your online EDS No Ft.48-3453/2015 (FCA) dated 16.06.2023 on the subject cited above.

In this context, the annotated reply of the observations/EDS pointed out vide communication referred to above is as below: -

Sr No.	EDS/Observation	Reply to EDS
1.	In point No. 2, Muck management plan has been found uploaded but the certificate regarding distance of proposed area from protected area has not been found uploaded	In this context, user agency has submitted that now certificate regarding distance of proposed area from protected area has been uploaded online against Additional information Details as "Wildlife Distance Certificate".
2.	In point No, 3 it was asked to mention correct working plan prescription in part-II Para 5, but same has not given	In this context, it is submitted that the working plan prescription has been uploaded in online Part II.
3.	In point No. 4, the detail of violation in Para 11 b& c is still not attended in part II.	In this context, it is submitted that the case has already been reported in Hon'ble High Court of HP in CWP No 5600/2012 and is included in the list of 2183 roads. The present case is for regularization of violation under FCA, 1980 and no fresh violation has been taken place.
4.	In point No. 5, it is correct that CA is proposed in Block Plantation but CA Scheme, digital map and KML file of proposed area out of compact block be uploaded at appropriate column.	It is context, it is re-submitted that CA Scheme is proposed as block plantation for which no option is available in the web portal. The CA has been charged with regards to per plant cost. Hence the same is uploaded against the additional information.
5.	In point No. 6, the bill of NPV and Penal NPV is not prepared on current rate issued on 06.01.2022. Further, the bill penal NPV has been prepared for 5 years only, whereas, violation took place more than 16 years. Hence revised the NPV and Penal NPV bill as per the current rate be uploaded online.	In this context, it is submitted that the Bill of Penal NPV has been prepared in view of the FCA Handbook Para 1.21 Sub para (ii) a which is correct and need not to be revised.
6.	The point No. 7 is still not attended.	It is context, it is re-submitted that CA Scheme is proposed as block plantation for which no option is available in the web portal. The CA

		has been charged with regards to per plant cost. Hence the same is uploaded against the additional information.
7.	In point No. 8, The Village Benefit certificate is found uploaded but the site inspection report is not in readable form	In this context, user agency has submitted that now legible copy of site inspection report has been uploaded online against Additional information Details.
8.	In point No. 9, the report of the committee constituted for regularization of violated case as per the direction of Hon'ble High Court found uploaded but the joint inspection report attached with it is not in readable form.	In this context, user agency has submitted that now legible copy of site inspection report has been uploaded online against Additional information Details.
9.	In point No. 10, Undertaking of user agency for providing the NoC/Sale deed/ Gift deeds may be provided online.	In this context, user agency has submitted that the undertaking for providing the NoC/Sale deed/ Gift deeds has been uploaded online against Additional information Details.

Further, the complete file is uploaded as additional information in online Part I. It is therefore requested to take up the matter with the higher ups to accord necessary sanction into the matter please.
