The undersigned is directed to refer to the State Government of Maharashtra's letter no. FLD-2021/CR-16/F-10 dated 04.03.2021 and the Desk-17/FCA-S2/PID-43985/Gadchiroli/3484 dated 19.03.2024, I am directed to inform that, Ministry vide notification SO 5074(E) dated 29.11.2023, certain activities for which State Government empowered to accord permission which includes Police establishments like Police Stations or outposts or border outposts or watch towers in sensitive area.

2 In view of the above, it is to inform that proposed activity under the subject proposal i.e. construction of administrative building and Residential Quarters of Arm Out Post will qualify as activity mentioned under Sl No xii or otherwise to be examined and may take appropriate decision as per the Ministry notification SO 5074(E) dated 29.11.2023 and provisions of Van (Samvardhan Evam Sanrakshan) Adhiniyam, 1980.

3 Further, it is to inform that, in case of proposed activities are not qualify to consider as per the SO 5074(E) dated 29.11.2023 and provisions of Van (Samvardhan Evam Sanrakshan) Adhiniyam, 1980, the proposal may be resubmitted to this office for further consideration and to seek clarification from the Ministry with reference to the provision of para 1.10 of the Comprehensive hand book.


