	There are various PAs surrounding the proposed project. Therefore, State Govt. may also review the proposal in pursuance of Ministry letter dated 07.06.2022 and may submit the Wildlife Management Plan along-with detail of its implementation in to the account of CAMPA is required to be submitted along-with Stage-I compliance. However, in case where is not possible for the State Govt. to submit the compliance due to the delay in preparation of such plan, a lump sum amount of 2% of the project cost shall be realized from the User Agency and submitted along-with the Stage-I compliance. While as per the Mining Plan and purpose wise breaking of forest land required for the project, no such areas have indicated in the proposal. Therefore, efficacy and rationale of submitting undertaking for an activity which is not a part of the project, clarification may be submitted by State Govt. in this regard.	In this regard, of user has informed that the said lease area falls in the river bed which has only sand, stone & gravel (bajri) etc. which will be sold in its entirety (fully utilize for sale), hence there is no justification in its case for muck dumpling.
