Processed proposal for diversion of 0.9614 ha for formation of approach road to the agriculture lands in Kapppahad Village of Ibrahimpatnam Mandal from Aghapalli to Kalwakurthy Highway in Amangal Division, Rangareddy District for formation of approach road to the agriculture lands was submitted to the State Govt. for onward submission to the IRO, vide ref 1st cited.

The State Govt. vide ref 2nd cited has raised certain EDS viz., requested to furnish a map showing availability of private / other lands adjacent to this RF for their approach road purpose.

The Conservator of Forests, Charminar Circle, Hyderabad vide ref 4th cited has submitted a map showing the location of the land and also approach road. Copies of the replies is enclosed herewith for necessary action and with a request to take further necessary action in processing the proposal.

Further, it is submitted that recently, the IRO, MoEF&CC, GoI, Hyderabad in similar proposal pertaining to (a) diversion of 0.8819 Ha of forest land in Amangal division for Formation of approach road in f/o Sri.Satya Prakash Rao (b) diversion of 0.53 Ha – for access to existing approach road to the agriculture lands in Ibrahimpur RF of Yadadri District in f/o Vidyasagar & (c) access of existing road from Srisailam Highway to Lemoor Village in Kandukur Mandal, Rangareddy District - 0.9717 Ha – in f/o TUMFOR AGRI FARMS LLP have accorded Stage-I approval, subject to imposition of

certain conditions mentioned therein. One of the condition stipulated is identification of equivalent non-forest land contiguous to existing forest land in Telangana shall be identified for CA purpose and such non-forest land shall be mutated in favour of the State Forest Department and handed over to the State Forest Department.

Hence, the User Agency is being requested to submit the details of the non-forest land identified for CA, soon after receipt of the same further details will be furnished.
