Therefore, State Govt shall submit the revised NPV bill/calculation sheet as per the dense vegetation density as mentioned in s.nO-4(1), Part-II. 6.	In reference of the observation No. 15, REPLY IS NOT ACCEPTED, Muck management plan has been submitted however, no reclamation plan found uploaded. 7.	In reference of the observation No. 23, REPLY IS NOT ACCEPTED, as per the DSS, State Govt proposed the DFL in 51.6 ha, however calculated area is 19.2 ha. Out of 9.60 ha (WL Sarahan) 01 ha. is under Very Dense Forest category (VDF) and in Kinnaur forest Division, out of 9.60 ha, 04 ha. is under Moderate Dense Forest category MDF. Also, the shape of the uploaded KML of the CA area is not matching with SOL, DGPS WL Sarahan Division. Therefore, State Govt. shall upload the correct and complete area of the proposed Compensatory afforestation area with vegetation density less than 40% with requisite documents (KML, SOIL & topohsteet, Land suitability certificate, Compressive CA scheme, revenue records etc.) duly authenticated by DFO concerned.
