I submit that, in the reference 3rd cited, hard copies of the proposals (i.e., diversion of forest land over 4.92 ha. for improvement to Kurupam Muliguda road to Beerupadu, Vizianagaram Division) were submitted to the Prl. CCF. In the reference 4th cited, the Prl. CCF (HoFF), AP, Guntur has noticed / communicated certain short comings, returned the proposals and requested to re-submit the proposals duly rectifying the same for taking further action. In this regard, the DFO, Vizianagaram has submitted report after attending the shortcomings and re-submitted the proposals in the reference 5th cited. The details are as follows:-

1) The authenticated map sheets are torn and also not counter signed by the field officers of the concerned division. Hence to be rectified.

The DFO, Vizianagaram has submitted the authenticated map (without torn) duly countersigned by the Field staff of the Vizianagaram Division in (5) sets. The map (without torn) was included in the proposals.

2) The Divisional Forest Officer, Vizianagaram in Part-II and in field inspection notes, has stated that, the road is passing in Deruwada RF with a length of 2410 m. in compt. Nos.150 & 151 Thatichidi R.F. with a length of 4510 m. in Compt. No.141, 142, 143 & 144. But in the authenticated map, compt. Nos.141, 142, 143, 144, 149, 150 and 151 only were shown excluding compt. No.146.

The DFO, Vizianagaram has reported, that the proposals are verified with reference to the authenticated map received from the GIS Wing, O/o the Prl. CCF (HoFF), AP., Guntur and informed that, as per the field verification, compartment no.146 is also touching. But, the Compartment no.146 was ignored in the authenticated map by the GIS wing. Further, the topo sheet maps submitted by the User Agency in which Compt.no.144 was typically ignored and which was included in their maps and countersigned by the DFO, Vizianagaram. Further, the total area of 4.92 ha which was authenticated by the GIS wing. The Compt. No.146, ignored in the GIS authenticated map, now included and countersigned by the DFO, Vizianagaram and requested to consider the proposals.

A copy of the report submitted by the DFO, Vizianagaram along with rectified maps / proposals are re-submitted herewith for consideration and necessary further action.
