2. In this context, it is submitted that the point wise reply to the observation raised vide your office letter under reference is furnished as under:-



1.	In Part-1A-3 (xvii), the name mentioned in the authorization letter does not match the details of the person making the application.	The user agency has submitted that all the Executive Engineers are authorized by the Engineer-in-Chief to make the application on the behalf of HPPWD.
2.	Administrative approval and approved DPF of the project from the competent authority needs to be provided.	The administrative approval has been uploaded in online Part-I by user agency at Sr. No. 36 of additional information.
3.	Afresh KML of the instant proposal needs to be provided in the polygon form f the diversion area as he proposed area for diversion is 1.9683 hac. while the calculated area is 0.3219 ha. Additionally, the forest/non-forest area and violated and un-violated part in a distinct color	The forest/non forest area and violated and un-violated area has been shown in a distinct color in a fresh KML and also uploaded in online Part-I by user agency.
4.	The component marked in the KML need to be similar to the information provided under column B 2.4. Therefore, the same may be reviewed and rectified.	The component marked in the KML has been reviewed and rectified under column B 2.4 by user agency.
5.	Under column C(iii) survey sheet No. on copy of the survey of India toposheet indicating the boundary of forest land proposed to be diverted needs to be authenticated by the concerned DFO	Under column C(iii) survey sheet No. on copy of the survey of India toposheet indicating the boundary of forest land has been authenticated by the concerned DFO and also uploaded in online Part-I by the user agency.

6.	Under column D(a) it is mentioned = 1.703 Km already constructed. However justification note uploaded does not reflect such information. Therefore, the same needs to be incorporated and uploaded afresh.	The violated area has been mentioned in justification note and also uploaded in online Part-I by the user agency at Sr. No. <u>21(a)</u>
7.	The document uploaded regarding the information details of the road mentioned "Nil" for the length of the road already existing/constructed out of the total length involved in the project. The same may be reviewed and uploaded afresh.	The violated area has been mentioned in details of the road and uploaded in online Part-I by the user agency at Sr. No. 23 of additional information.
8.	Muck management plan needs to be duly authenticated by the concerned DFO.	The muck management plan is authenticated by the concerned DFO and also uploaded in online Part-I by the user agency at Sr. No. 34 of additional information.
9.	Reclamation plan for the dumping for the dumping site proposed in forest area needs to be uploaded which is to be duly authenticated by the concerned DFO.	Reclamation plan for the dumping site is also authenticated by the concerned DFO and uploaded in online Part-I by user agency.
10.	The layout plan has been provided. However, it does not match the KML provided. Therefore, a digital copy of the layout plan in an appropriate scale which must include a legend and the proper dimensions of each component, such as carriageway, paved shoulder, earth filling, drain and protection works, well as area wise calculations and forest/non forest area in different colors duly authenticated by the concerned DFO needs to be uploaded.	The new layout plan in an appropriate scale has been uploaded in online Part-I by the user agency at Sr. No. <u>27</u> .
11.	As per the details provided under column II of online portal Part-II and the site inspection report from the concerned DFO revealed that a violation has been carried out. Therefore, in view of the above, the following clarification/justification may be provided. The action taken report against the violators as per Para 1.21 (a) and or (ii) of FCA guidelines may be submitted/uploaded in the portal in ii. Action taken by the state government against the official concerned for not being able to prevent the use of forest land for non-forestry purposes	The action taken report against the violators as per Para 1.21 (a) and or (ii) of FCA guidelines may has been uploaded in the web portal.

	without prior approval of Govt. of India.	
12.	Under column 4(ii) the number of trees to be felled proposed is mentioned as 55. However as per the violation note the number of trees to be felled is 48. Therefore, the same may be reviewed and justified.	The necessary correction has been made now.
13.	A complete enumeration list of trees with compartment number alongwith the date of enumeration clearly mentioned and authenticated by the concerned DFO needs to be uploaded.	The complete enumeration list of the trees alongwith date, compartment & khasra wise has been uploaded in online Part-II at Sr. No. <u>13</u> .
14.	Information provided under column 6 of the Part-II online needs to be properly filled.	Needful has been done now.

It is, therefore, requested that the proposal may kindly be sent to GoI for according stage-I approval under Section 2 of Forest (Conservation) Act, 1980.
