Sir,

In inviting a reference to GoI, MoEF & CC, Regional Office, Bhubaneswar letter cited above on the captioned subject, the DFO, Boudh / Phulbani Forest Divisions and RCCF, Berhampur Circle have furnished the compliance to GoI observations as detailed below-:

Observation 1-: The State Govt. shall carry out joint inspection involving forest, revenue and OPTCL officials to ascertain actual number of towers erected along with GPS co-ordinates and extent of forest area used thereon, in violation of Forest (Conservation) Act, 1980.

<u>Compliance:-</u> The DFO, Boudh Forest Division has reported that the joint site inspection involving Forest, Revenue and OPTCL officials has been conducted on dt. 26.10.2023 to ascertain the actual number of towers erected on forest land proposed for diversion without prior approval of the competent authority under Forest Conservation Act, 1980. The list of towers with GPS coordinates and extent of forest area used thereon is enclosed as **Annexure-I**.

Further, the DFO, Boudh Forest Division has reported that during the preliminary site inspection, 10 (ten) numbers of transmission towers were found to be erected on forest land amounting to violation of Forest Conservation Act, 1980. However, during the re-verification of the tower locations, the Tahsildar, Boudh has certified Plot No. 81, Khata No. 15 of Samapaju village as non- forest land, thus bringing down the number of towers to 9 (nine) which is mentioned at **Annexure-I**.

The DFO, Phulbani Forest Division has reported that the joint site inspection involving Forest, Revenue and OPTCL officials was carried out, the report of which is enclosed as **Annexure-I A**. The DFO, Phulbani Forest Division has reported that all the violations were found on Revenue Forest Land which were never reported by the concerned Revenue Authority and / or User Agency.

Observation 2-: Detail action taken report on violation of FC Act, 1980 in both Boudh and Phulbani Division with name and designation of erring officials responsible for violation causing diversion of forest land for non-forestry purpose may be furnished.

<u>Compliance:</u> - The DFO, Boudh Forest Division has reported that Show cause notice has been issued to Sri Prafulla Kumar Pati. Ex-DGM (Elect), EHT (Const.) Division, Angul vide his office letter no. 6996 dt. 19.11.2023 for violation of Forest Conservation Act, 1980. (Copy Enclosed as **Annexure-II**).

The Collector and District Magistrate, Boudh has been requested by DFO, Boudh Forest Division vide his office letter no. 7000 dt. 19.11.2023 to initiate action against the erring official responsible for violation as per the local prevailing laws. Subsequently, the Tahasildar, Boudh Tahasil and Tahasildar, Harabhanga Tahasil have initiated encroachment cases against the erring official i.e. Sri Prafulla Kumar Pati, Ex-DGM (Elect), EHT (Const.) Division, Angul under Odisha Prevention of Land Encroachment Act, 1972 communicated to this office vide letter no. 329 dt. 29.01.2024 and letter no. 292 dt. 16.01.2024 of Tahasildar, Boudh and Tahasildar, Harabhanga Tahasil respectively. (Copy Enclosed as **Annexure - III**).

The DFO, Phulbani Forest Division has enclosed a copy of letter No.180 dated 12.01.2024 of Collector, Kandhamal wherein it has been reported that encroachment cases have been booked by Tahasildar, Phulbani and Khajuripada against unauthorized construction of electric towers by OPTCL on Forest Land under Khajuripada and Phulbani Tahasil. The action taken reports are enclosed as **Annexure-III A**.

1. The state Govt. Shall carry out joint inspection involving forest, revenue and OPTCL officials to ascertain actual number of towers erected along with GPS co-ordinates and extent of forest area used thereon, in violation of Forest (Conservation) Act, 1980.

The joint site inspection involving Forest, Revenue and OPTCL officials has been conducted on dt. 26.10.2023 to ascertain the actual number of towers erected on forest land proposed for diversion without prior approval of the competent authority under Forest Conservation Act, 1980. The list of towers with GPS coordinates and extent of forest area used thereon is enclosed herewith. (copy enclosed as Annexure - I)

Further, it is to mention here that, during the preliminary site inspection 10 (ten) numbers of transmission towers were found to be erected on forest land amounting to violation of Forest Conservation Act, 1980. However, as per instructions laid in the letter No. 5-ORC592/2023-BHU of Integrated Regional

Office, Bhubaneswar during the re-verification of the tower locations the Tahsildar, Boudh certified Plot No. 81, Khata No. 15 of Samapaju village as nonforest land, thus bringing down the number of towers to 9 (nine) as mentioned in the *Annexure – I*.

2. Detail action taken report on violation of FC Act, 1980 in both Boudh and Phulbani Division with name and designation of erring officials responsible for violation causing diversion of forest land for non-forestry purpose may be furnished.

Show cause notice has been issued to Sri Prafulla Kumar Pati, Ex-DGM (Elect), EHT (Const.) Division, Angul vide this office letter no. 6996 dt. 19.11.2023 for violation of Forest Conservation Act, 1980. (Copy Enclosed as Annexure-II).

The collector and District Magistrate, Boudh has been requested to initiate action against the erring official as per the local prevailing laws vide this office letter no. 7000 dt. 19.11.2023. Subsequently, the Tahasildar, Boudh Tahasil and Tahasildar, Harabhanga Tahasil have initiated encroachment cases against the erring official i.e. Sri Prafulla Kumar Pati, Ex-DGM (Elect), EHT (Const.) Division, Angul under Odisha Prevention of Land Encroachment Act, 1972 communicated to this office vide letter no 22 dt. 16.01.2024 of Tahasildar, Boudh and Tahasildar, Harabhanga Tahasil respectively. 

Sir,

With reference to the subject cited above, during the course of Joint Site Inspection held on dt. 13.04.2023 by the Forest & Revenue officials, it was observed that the towers have been erected with transmission line in Revenue Forest kissam land proposed for diversion without prior approval of the competent authority. Hence, from the circumstantial evidence you have been found prima facie guilty in contravention of section (2) of Forest Conservator of Act, 1980.

The above violation attracts the provisions of Para 1.21 (i) (a) which states "a. The diversion of forest land for non-forestry purposes without the prior approval of the competent authority in the State will be dealt under the provisions of Indian Forest Act 1927 and other State Acts dealing with the conservation of Forests by the State government concerned. The land in question will not be considered as diverted under FCA 1980 and the status of the land shall continue to be forest."

H

In view of the above, it is asked upon to show cause as to why legal action shall not be taken as per prevailing laws. Your reply should reach this office immediately for taking further course of action at this end.






