In part- B-1 of part-1 pertaining to past proposal the detail of the proposal under consideration has been given which his incorrect	User agency has informed that no earlier proposal for diversion of forest land was submitted in the past. The same may have been mentioned by mistake in the system and accordingly, reference of past forest proposal coming under B-1 of Part-I has now been removed and is now showing as NIL.
2.	Map of SOI top sheet uploaded at para-C (III) of online part-1 has not been authenticated by DFO, Govind Wild Life Sanctuary Division and the representative of user agency.	User agency has mentioned that map of SOI top sheet uploaded at para-C (III) of online part-1 has been authenticated by user agency and DFO, Govind Wild Life Sanctuary Division and enclosed as <b>Annexure - I</b> and also uploaded in online proposal.
3.	Map of SOI top sheet uploaded at para-C (III) of online part-1 has not been authenticated by DFO, Tons forest division and the representative of user agency.	User agency has mentioned that Map of SOI top sheet uploaded at para-C (III) of online part-1 has been authenticated by user agency and DFO, Tons Forest Division and enclosed as <b>Annexure - II</b> and also uploaded in online proposal.
4.	Although the copy of CAT plan has been uploaded at para-M (ii) (b) but the same is not opening.	User agency has mentioned that needful correction has been done by user agency and CAT Plan has been re-uploaded at para -M (ii) (b) of part - 1 and also uploaded as additional information .
5	Enumeration list of trees present at FRL has been uploaded at para-4 (ii) of online part-ii but the detail of trees at FRL -2 mtr and FRL-4 mtr has neither been found uploaded nor provided in hard copy. A certificate of DFO that not tress is in the area proposed for barrage is required to be submitted.	DFO Govind Wild Life Sanctuary Division has certified that no trees are coming in FRL - 2 mtr and FRL - 4 mtr. Necessary certificate is enclosed as <b>Annexure - III</b> and uploaded as additional information in form A part -ii.



6.	Brief note on vulnerability of the forest area proposed for diversion to erosion given para-6 of online part-ii is not appropriate. Which is required to be correct?	DFO Govind Wild Life Sanctuary Division and DFO Tons Forest Division have made necessary corrections in para-6 of online part –II.															
7.	As per detail given in para-13 online part-2. CA has been proposed in Govind Wild Life Sanctuary as per detail given below- I. KaslaComptt. No. 2-20 ha. II. JakholComptt. No.7-15 ha. III. UnaniComptt. No. 4 (b)- 15 ha. 8.	Geo reference map and map in SOI toposheet uploaded at para-13 have not been authenticated by the DFO.	DFO Tones forest division has submitted that revised Geo reference map, digital map, CA scheme and site suitability certificate duly authenticated by DFO is enclosed as <b>Annexure – V</b> and also uploaded in para 13 of part –ii.															
9.	DFO. Tons Forest Division has not given the name of working circle in para-5 of online part-ii and brief not on vulnerability of the area to erosion also not appropriate.	Correction has been done in form A Part-II by DFO.															
10.	It is seen from the data given in part-14 of online para-ii i.e. District profile that the CA stipulated (2548.06 ha) is not commensurate to the forest land diverted (1653.08 ha) logically. CA stipulated is double the area of forest land diverted.	Correction has been done in form A Part-II by DFO.															
11.	Name and designation of the officer has not mentioned in the recommendation of the state govt. uploaded at para-16 of online part-ii. Official seal has also not been affixed.	Correction has been done in part-V, copy enclosed.															
12.	Majority of the documents provided in the hard copy of the proposal are photocopy.	All documents have already been submitted in original. The additional documents required are being enclosed herewith as per above details.															
13.	Yes is mentioned against para-12 of part-ii of Govind Wild Life and National Park regarding violation. Which need correction.	Yes has been wrongly mentioned in para-12 of online part-II of Govind Pashu Vihar Division which can not be corrected due to system error. DFO has submitted that there is no violation as already provided in site inspection report of Dy. Director Govind Pashu Vihar and also uploaded as additional information of part –II.
