

On the subject and reference cited above, kindly find enclosed herewith the letter received from the User Agency vide No. 7785-86 Dated: 08.10.2022 (copy enclosed) regarding the EDS raised by the IRO, Jammu. The User Agency has accordingly reduced the length of the road alignment viz., Bani to Billawar via Dhaggar, Dhaman & Deri Gall under CRF (Phase-Ist) District Kathua from 6.00 Km to 5.00 Km. Now they have requested to make necessary amendments in the Form-'A' (Part-1) of PARIVESH portal so that the changes can be incorporated in Form-'A' (Part-1) accordingly.



With the content of above noted subject and proposal IRTTO Jammu has raised EDs that the stretch of 6.00 km road of proposed road is not plausible in absence of written approval of 6.00 km of road.

Now as per EDs and DPR we have reduced the length of the proposed from 6.00 km to 5.00 km (in the KML file) as a result of which the Forest area has been reduced from 2.5453 hac to 1.505 hac. We are trying to make an amendment /recast in Form-A Part-I in the Parivesh Portal with report of the Forest area but not able to modify the same as the edit option is not working.

It is as such requested to your goodself kindly allow to make necessary amendment for the same in Form-A Part-I of Parivesh Portal.
