In obedience to the reference 3rd and 6th cited, it is submitted that in the reference 8th cited, the Forest Range Officer, Kanigiri has submitted report stating that the Proposals for Quartz Mining Lease applied by Sri.P.Babul Reddy is located in Compt.No.450 which is adjoining of the Yerrakonda Reserve Forest and the distance from the Reserve Forest boundary is 0.61 Kms to the Station No.S4 of DGPS Survey Map.
