Sub:- Submission of proposal for diversion of 4.837 ha of forest land for construction of 132/33 KV Transmission line from Grid sub-station Boudh to proposed 220/132/33 KV Grid Sub-station at Kiakata of Athmallik Division.



Inviting a reference to the memo cited above on the subject, this is to intimate that the Divisional Forest Officer, Athmallik Forest Division vide his Memo No.5042 dated 23.8.2023 has complied the observation made vide your memo under reference and submitted revised proposal for diversion of 4.837 ha of forest land for construction of 132/33 KV Transmission line from Grid Sub-Station, Boudh to proposed 220/132/33 KV Grid sub-station at Kiakata (**Copy enclosed**). The point-wise compliance is furnished below :-

1. (A) The User Agency has revised the forest land to be diverted for 4.837 ha instead of 5.185 ha in respect of Athmallik Forest Division. Accordingly the Form A (Part-I) has been rectified.
(B) In case of requirement of 0.69 ha of non-forest land in village Damodarpur, it has been revised to 0.292 ha in respect of village Baradakata and thus village Damodarpur has been deleted and village Baradakata has been included in the village list as per Land scheduled furnished by the Tahasildar, Athmallik.
2. In case of requirement of non-forest land of 46.701 ha (Boudh Division-9.06 ha. and Athmallik Division- 37.641 ha.), it has been revised to 44.412 ha (Boudh-9.044 ha and Athmallik-35.368 ha) as per land schedule furnished by the Tahasildar, Athmallik .

Therefore the revised Diversion Proposal submitted by the DFO, Athmallik Division duly complying the observation is forwarded herewith in three sets for favour of information and necessary action.


