Kind attention is invited to the references 3<sup>rd</sup> and 4<sup>th</sup> cited, wherein the State Government has issued instructions to inform the action taken against all the authorities / persons responsible for the violations occurred in the alignment of OFC where trench was dug in Puduru RF by M/s Vindhya Telelinks Ltd. (0.52 ha) and in the same alignment by M/s Reliance Jio Infocom Ltd. (1.27 ha), under Section 3A and 3 B of Van (Sanrakshan Evam Samvardhan) Adhiniyam, 1980.

The Conservator of Forests, Tirupati Circle, Tirpuati vide references 6 <sup>th</sup> and 7<sup>th</sup> cited (copies enclosed) has submitted detailed action taken report for the violations occurred in OFC alignment where trench was dug in Puduru RF, which is as follows;

## i) FP/AP/OFC/37050/2018 - Vindhya Tele Links Ltd.: (0.52 ha):

In respect of diversion of 0.52 ha of forest land in Kanupuru East RF, Surveypalli RF, and Surveypalli Extension RFs of Nellore Range, Nellore Division and Puduru & Yellasiri RFs of erstwhile Venkatagiri Range (now in Tirupati Division), a charge sheet was filed on 17.05.2025 before the Hon'ble JMFC, Naidupeta, against two accused persons under Section 20(1)(c) of the Andhra Pradesh Forest Act, 1967; Sections 3A and 3B of the Forest (Conservation) Act, 1980; and Rule 15 of the Van (Sanrakshan Evam Samvardhan) Rules, 2023.

## ii) FP/AP/OFC/38865/2019 - Reliance Jio Infocomm Ltd. (1.27 ha):

In respect of diversion of 1.27 ha of forest land in Nellore, Venkatagiri, Udayagiri, Kavali, and Atmakur Ranges of Nellore Division, the violation occurred in Puduru & Yellasiri RFs of Naidupeta Range, Tirupati Division.

A charge sheet was filed on 04.08.2025 before the Hon'ble JMFC, Naidupeta, against one accused person — under Section 20(1)(c) of the Andhra Pradesh Forest Act, 1967; Sections 3A and 3B of the Forest (Conservation) Act, 1980; and Rule 15 of the Van (Sanrakshan Evam Samvardhan) Rules, 2023.

It is to inform that, charge sheets have been filed in both violation cases and requested to forward the same to the MoEF&CC, IRO, Vijayawada for further action as per the provisions of the Van (Sanrakshan Evam Samvardhan) Adhiniyam, 1980, and Rules, 2023 as deemed fit.
